Mr. William Bullard and Ms. Rielle Waters-Santinelli, volunteer 4-H leaders, also expressed their gratitude to the Board for their support and encouraged those present to attend the Amador County Fair and Junior Livestock Auction.

Ms. Jennifer Georlitz, UCCE/4-H Coordinator and Mr. Larry Fossen, retired UCCE/4-H Coordinator, also thanked the Board for their support and stated currently Amador County has 144 4-H members and 43 volunteer leaders. Ms. Georlitz stated new volunteers are always welcome.

<u>Senate Bill 296</u>: Supervisor Novelli spoke on behalf of Mr. Terry Sanders, Veterans Service Officer, and requested the Board consider supporting the subject legislation. He stated existing law requires funds to be disbursed each fiscal year on a pro rata basis to counties that have established and maintained a county veterans service office in accordance with the staffing level and workload of each county veterans service officer, under a specified formula. He noted this

bill would appropriate the sum of \$9,000,000 from the General Fund to the Department of Veterans Affairs for the disbursement to counties to fund the activities of county veterans service.

Amador County Museum: Supervisor Plasse took this time to mention the Amador County Museum is now open to the public and encouraged everyone to take the opportunity to visit. He thanked the Amador County Historical Society and many volunteers for countless hours of labor in completing the project.

Amador Community College: Supervisor Plasse reported thirty-three (33) students are currently enrolled for the 2013 fall semester focusing on various areas of study.

Amador County Civil Grand Jury's Final Report: Discussion and possible action relative to presentation of the 2012-2013 Amador County Civil Grand Jury's Final Report.

Ms. Marianne Bourgeois, Foreperson of the 2012-2013 Amador County Civil Grand Jury, presented the Board with the Grand Jury's Final Report.

Supervisor Plasse commended Ms. Bourgeois and the entire Grand Jury for presenting a very fair minded and objective report. He stated sometimes grand jury complaints can be politically and ideologically based which makes the job of the Grand Jury difficult. However, he stated the 2012-2013 Grand Jury was able to go through fifteen complaints and investigate and respond in a fair and objective manner. In addition Supervisor Plasse stated in years past the Board of Supervisors has received a list of potential grand jurors and given the opportunity to

provide comments relative to certain potential jurors to the Court and the presiding judge on preferred juror selections. He noted that this year when he inquired as to the preferred format of the responses (i.e.; written/verbal, etc.) he was presented with a question as to why this process is necessary. He sated the Board has many years of cumulative knowledge of a vast number Amador County residents and feels the input of elected officials is valuable in selecting a fair and impartial jury. He stated to date he has not received a response back from the presiding judge relative to his question and would like to ensure that the Board continues to be provided with a list of potential jurors in the future. Ms. Bourgeois stated she would relay these comments to the presiding Judge as she was not aware of this past protocol. Supervisors Oneto and Novelli also thanked the 2012-2013 Grand Jury for their service.

Resolution opposing the United States Fish and Wildlife Services proposal to list the Sierra Nevada Yellow-Legged Frog as endangered throughout its range

Community Development Agency: Discussion and possible action relative to alternative selection and grant application preparation regarding the Fiddletown Road at Shenandoah Road intersection.

Mr. Jered Reinking, Senior Civil Engineer addressed the Board and summarized this matter for the Board. He stated this project is identified in the current CIP and in April 2013 Caltrans advised projects for HSIP funding were being accepted. Mr. Reinking stated at that time County staff met with City of Plymouth representatives to develop potential options for improving the intersection. He continued by stating if the Board chooses and approves preferred option today staff will be seeking direction on the HSIP application itself. He stated the Board can direct staff to move ahead with the application and submit by the end of July working in tandem with the City of Plymouth, or choose to submit at a later date with the County being the lead agency and applicant. Mr. Reinking then presented the following preliminary alternatives (options) as candidates for nomination for the HSIP:

OPTION 5: Minor Build

Under this option, the Fiddletown/Shenandoah Rd. intersection will remain relatively the same with the exception of minor alterations to shoulder areas and median area at the intersection. The shoulders along the curve of Shenandoah Road will be widened to allow for more horizontal space for vehicles traveling in each direction (increasing recover area in cases of vehicle drift). The existing median area will be modified to create a more prominent feature in the roadway delineating the intersection movements.

OPTION 6: Full Build

This option proposes to shift the Shenandoah Rd. alignment northwest relative to the current alignment. Shenandoah Rd. profile will remain relatively low to the original ground. A new leg of Fiddletown Rd. will be constructed to intersect Shenandoah Rd. that will maximize the horizontal length of the new leg to provide more satisfactory geometric conditions. Shenandoah Rd. will remain a free flow through movement, while Fiddletown Rd. is proposed to be stop controlled at the intersection with a wide shoulder area for vehicles making right turns toward Fiddletown. Shenandoah Rd. will remain a two-lane road (one lane in each direction) with dedicated left turn pocket at the intersection. This option includes the acquisition of right-of-way.

Cost Estimate:

OPTION 5 Minor Build=\$240,000 OPTION 6 Full Build=\$1,660,000*

*Cost does include the "Left turn lane to Fiddletown"=\$230,000.00 *Dost <u>does not include</u> the "Free through lane to Fiddletown"=\$210,000.00

At this time Ms. Rebecca Neilon, Dokken Engineering reviewing the options in more depth and fielding questions from the Board.

<u>ACTION</u>: Direction given pursuant to the following motion.

<u>MOTION</u>: It was moved by Supervisor Oneto, seconded by Supervisor Plasse and unanimously carried to direct staff to move ahead with applying for the HSIP funding grant and approving Option 6-(Full Build) as the preferred alternative including the left turn lane to Fiddletown; and with the caveat that if the project becomes financially unfeasible the application can be withdrawn or Option 5-(Minor Build) can be considered. The County would be responsible for 10% of incurred costs up to the point of termination of the application or relinquishment of grant funds. Absent: Supervisor Forster
