2. Communicable Disease Update- Lori Jagoda

The latest CD Brief indicates flu is "widespread" in California. 90% of cases with available lab data in US have matched current flu vaccine strains. There have been three outbreaks in congregate settings in California.

7. Plan Updates

Epidemiology Surveillance Plan- Michelle Opalenik

The triggers and tracking mechanisms of the 2013 Epidemiology and Surveillance Response Plan was highlighted. Discussion took place under what conditions Public Health should be notified. Michele discussed the advantage of having "triggers" outlined in a written policy.

Extreme Temperature- Timothy Skaggs

Tim reported on progress of the Extreme Temperature Plans. He is available to work with agencies to help disseminate preventive information to their clients.

Partner Prophylaxis- Lori Jagoda

Lori explained that a Push Partner is an agency who would provide emergency prophylaxis to their employees, employee family members, in-patients, residents, or other clients. Push Partners help distribute needed emergency prophylaxis to county residents and insure that their own agency is well protected. Continuity of Operations (COOP) Plans- Marsha Stone

Marsha stressed the importance of having a Continuity of Operations Plan in place. She encouraged all partners who have such a plan, to use the attached form to evaluate the effectiveness of their COOP planning during the recent power outage. For agencies that do not have COOP plans in place, she provided a list of first steps to develop such a plan.

8. California Public Health and Medical Emergency Operations Manual- Marsha Stone

The new guidelines from the state are encouraging healthcare partners to initiate situational reporting by reporting the following to public health in any incident:

- Estimated number of people affected
- Estimated number of fatalities
- Estimated number injured requiring immediate care
- Estimated number injured not needing immediate care
- Estimated number injured with minor injuries
- Facility status (fully functional, not functional, partially functional)
- Status of facility access (fully functional, not functional, partially functional)
- Status of facility communications system (fully functional, not functional, partially functional)
- Do you have power
- Do you have water
