A. **Assessor's Office / Secured Roll Corrections**: Approval of the following: APN 033-010-012-000 (OAS Family Trust Dated 1984-OAS, Harold Trustee).

3. **RESOLUTIONS**

- A. **Treasurer/Tax Collector**: Approval of a resolution authorizing *Sale of Tax-Defaulted Property at Public Auction* for non-payment of secured property taxes, pursuant to State Law (Section 3691, et seq, Revenue and Taxation Code.
- B. **District Attorney**: Approval of a resolution recognizing Toni Linde as the Amador County *Citizen of the Year* for 2013.
- C. **Sheriff's Office**: Approval of a resolution recognizing and honoring Sergeant Andrew Thomas Mendonsa upon being named Amador County *Peace Officer of the Year* for 2013.

On Tuesday, September 24, 2013, the Board awarded RFP 13-13 and approved contract to *SCS Engineers* in an amount of \$132,332.00 for 3 years for Environmental Consulting and Contracting Services the Amador County Landfill in Ione, CA.
