### 3. **RESOLUTIONS**

A. **Community Development**: Approval of a resolution accepting work completed by R. A. Nemetz Construction Company for the spall repair and bridge top rail repairs at the Sutter Creek Road Bridge (Bid #14-04) on October 16, 2014; and authorize the Chairman to sign three (3) original copies of the Agreement and Release of Claims.

# 4. **AGREEMENTS**

- A. **Sheriff's Office**: Approval of an agreement with Samantha Hens, Ph.D. to provide forensic anthropology services to the Amador County Coroner's Office.
- B. **Sheriff's Office**: Approval of an agreement with the State Department of Parks and Recreation for conducting Off-Highway Vehicle patrol/enforcement within Amador County.
- C. **Sheriff's Office**: Approval of an agreement with the California Department of Corrections and Rehabilitation (CDCR) and the Amador County Sheriff's Office (ACSO) allowing the ACSO to house approved, long term, Amador County Inmates to CDCR fire camps at a cost of \$81 per day for the 38 day training period and \$10 per day thereafter.
