We are currently in the process of assessing the mineral rights for Unimin Corporation, on Howard Properties and we need \$17,126 to pay off last year's balance for the mineral rights appraisal. The additional amount needed to complete the balance of the mineral rights appraisal is estimated to be from \$27,360 to \$34,320. We estimate a more specific amount to be \$30,000 for a total of \$47,000 needed for the mineral rights appraisal.

The legal work estimate from the attorney, Brett Price was estimated to be \$75,000 to completion. I think his estimate is at the high side and would not expect to use it all.

To get through this year, I would like to request \$46,000 for the appraisal work and \$75,000 for the legal.
