**2016-2017 Proposed Budget**: Discussion and possible action relative to review and direction to staff regarding the 2016-2017 Proposed Budget. (Recommended Budget will be presented for adoption a the June 14, 2016 Board Meeting)

Discussion ensued with the following actions being taken.

Ms. Thomi Manzano and Mr. Paul Molinelli Jr., Chamber of Commerce, addressed the Board and requested an increase in the Chamber budget from the currently budgeted \$25,000.00 to \$40,000.00. Ms. Manzano stated the additional funding will be used primarily to fund additional staffing within the office.

**ACTION:** Direction given pursuant to the following motion.

MOTION: It was moved by Supervisor Boitano, seconded by Supervisor Morgan and unanimously carried to decrease the currently budget amount to Amador Council of Tourism of \$104,500.00 (1910-54110) by \$3,000.00 and decrease the currently budgeted amount of \$2,000.00 (1910-54111) to the Film Commission and increase 1910-54109 (Chamber of Commerce) by \$5,000.00 for a total budget of \$30,000.00. Absent: Supervisor Forster

Further discussion ensued with Ms. Kathi Toepel, Common Ground addressing the Board and requesting an increase to Common Ground budget (1910-54112) from \$6,000.00 to a total of \$15,000.00 to offset costs associated with, but not limited to, preparing and delivering meals.

Ms. Susan Manning A-PAL, addressed the Board and requested an increase in the amount of \$5,000.00 to the A-PAL budget (1910-54112) spay neuter dog/cat program for low income Amador County residents. The budget is currently set at \$5,000.

Supervisors encouraged Ms. Manning to request contributions from individual Supervisors coming from discretionary funds.

Amador County Tree Mortality Hazard Tree Removal Plan: Discussion and possible action relative to approval of the subject Plan.

Supervisor Morgan presented this item to the Board and stated the Amador County Tree Mortality Core Planning team has been working on a Draft Amador County Tree Mortality Hazard Tree Removal Plan, which is before the Board today for possible approval. She stated the team used the Tuolumne County Plan as a template and has modified it to reflect the needs of

Amador County, but the Team welcomes Board input as to refining the document as it moves forward. She did note that the Plan is a "living document and will be evaluated and possibly amended as the process of obtaining eligibility for monies it moves forward. Supervisor Morgan also noted that in order to move forward with Cal OES and securing state emergency monies, the Plan must be adopted by the Board and submitted to Cal OES.

Discussion ensued with the Board recommending the following changes be made to the Tree Mortality Hazard Tree Removal Plan:

### Page 3:

# **Hazard Tree Removal on County Owned and Maintained Properties**

The County of Amador will identify and remove mitigate dead and dying trees due to drought and successful bark beetle infestation. This process will continue as the number of hazard trees increases. Public safety and continuity of essential services (power, water, communications, roads, etc.) are of primary concern. Therefore, County resources will be focused in the following areas:

- > Roads
- County Facilities
- Heliports

Amador County will assess all County owned and maintained infrastructure for dead and/or dying trees due to drought and bark beetle infestation within 200 feet of infrastructure. Registered Professional Foresters (and/or licensed Arborists) will inspect trees for successful bark beetle attack and designate trees for removal mitigation.

# Removal and Disposal of Trees, Slash and Wood Products

Removal and disposal of wood products is one of the most difficult aspects of the hazard tree removal process as resources are very limited. However, there are several tools available locally to assist in the removal of trees and slash. The following resources are available to Amador County. The following represents a cross section of some resources that are available to Amador County:

- ➤ Sierra Pacific Industries
- ➤ AMPINE (Division of Timber Products)
- ➤ Smith Grinding Partnership
- Licensed Timber Operators (Tree Removal Companies)
- Licensed Foresters and Arborists
- Individual Property Owners
