#### **MISCELLANEOUS MATTERS**:

<u>Election of Officers:</u> Director Gonsalves asked if any of the Board members would be willing to fill the Chair position. Director Herfel offered to fill the position leaving the Vice Chair seat vacant.

<u>Prop 172 Monies:</u> Director Herfel wanted to know how the Prop 172 monies are being dispersed. Discussion ensued regarding the County Board of Supervisors being responsible for determining how the monies are disbursed.

Chief Bellerive, Amador Fire Protection District, explained to the Board the history of Prop 172 monies being used for Dispatch and \$256,000.00 annually for the Amador Plan engine housed at Station 114 in Pine Grove.

Director Herfel stated that the Jackson Valley Fire Protection District Board has a problem with one district getting any monies from Prop 172 unless all districts receive monies.

## **PUBLIC MATTERS NOT ON THE AGENDA CONTINUED:**

<u>Measure M Monies:</u> Director Gamble voiced a concern that as population grows within city limits throughout the County would the distribution of Measure M funds become imbalanced for the rural districts.

Director Gonsalves noted that any ideas to change how Measure M monies are disbursed would need to go before County Counsel as the verbiage on the ballot voted on by the people of Amador County was specific.

<u>New Lockwood Chief John King:</u> Director Koos-Breazeal announced that there is a new Chief for Lockwood Fire Protection District, Chief John King.

**Establishing a Countywide Fire System:** Director Gonsalves asked if there was any update for establishing a countywide fire system. There was no update.
