Many local sponsors have been generous in providing funds for the event which will showcase Amador County.

Sara Forgette, Executive Director of Amador Arts, reported that Amador Arts has the opportunity to submit a grant from the National Endowment for ARTS. This "Our Town" Grant for \$60,000.00 would be used to develop a Community ARTS Plan and a Cultural Asset Map. Maureen Funk, Amador Council of Tourism, has said that she would like to work with ARTS for this program.
