Free Speech: Mr. Wendell Peart, District IV resident, addressed the Board and commented on the Board's action of reducing the public's opportunity to speak under Public Matters not on the Agenda from five minutes to three. Mr. Peart stated this action reduced the public's free speech by 40 percent and in his opinion is a violation of a person's civil right as spelled out in the Constitution's Bill of Rights. Mr. Peart requested his Supervisor Frank Axe take this matter to the Chairman of the Board and request the increase in speaking time be added to an upcoming Board Agenda.

#### **REGULAR AGENDA**

**Tree Removal on County Roadways**: Progress report by Mr. Ed Struffenegger, Registered Professional Forester, regarding dead tree removal along County roadways.

Mr. Ed Struffenegger, Registered Professional Forester, provided an update on the pilot project that is beginning in the Joyce Road area towards the lower end of Defender Grade and close to Highway 26. Mr. Struffenegger stated the goal of the pilot project is to work through the process beginning with right of entry forms being issued and returned, through the final cleanup phase. He noted he hopes the pilot project will allow the team to work through all of the unexpected elements and provide the opportunity to work through any issues that might need to be resolved for subsequent projects down the road. Mr. Struffenegger stated that right of entry forms have been received from all three property owners for the pilot project, but emphasized the importance of these forms as the project moves forward. He stated community meetings are planned in the future to encourage property owners to be timely in returning the forms before any work can be done on their properties. He continued by noting a sample contract and Request for Proposal is being drafted by Mr. Jon Hopkins, General Services Director at this time and will be ready to send out to potential contractors in the near future. He stated once the successful bidder is chosen a Notice to Proceed will be issued and the required insurance and other mandatory requirements will be submitted before work can begin. He stated this will be a regulated CalFire operation and inspections will be complete and the forest practice rule book will be followed in all cases. Mr. Strufennegger stated he looks forward to a good working relationship with CalFire as the project moves forward.

**Panther Fuels Reduction and Forest Health Project:** Discussion and possible action relative to the subject project and the Environmental Assessment prepared by the Amador District of the Eldorado National Forest.

Supervisor Oneto advised he owns land near the subject project. Therefore, he recused himself to avoid any potential conflict of interest issues.

Mr. Rick Hobson, Amador Ranger District Ranger, provided a brief update relative to the Memorandum of Understanding between the County and the United States Forest Service (USFS). He stated the MOU was established in 2012 and is intended to improve communication and coordination between the two entities. He stated he will continue to follow the MOU and has a meeting set up with Supervisors Oneto and Morgan in the near future to discuss any issues or answer any questions the County may have. He stated the MOU does expire at the end of this calendar year but with the Boards direction he can bring it back for approval of another five year term

Mr. Hobson continued to address the Board relative to the Panther Fuels Reduction and Forest Health Project. He stated the project is located on the western end of the Amador Ranger District along Panther Creek. He noted the intention of the project is to address fuel loading and

create fuel breaks, improve forest health by thinning the forest and increase access and maintain and reconstruct roads. Mr. Hobson stated the Amador District of the El Dorado National Forest has prepared an Environmental Assessment for the project and a comment period is being provided and is intended to provide those interested in or affected by this action an opportunity to make their concerns knows prior to a decision being made by the Responsible Official on the alternatives analyzed in detail. He stated he welcomes comments individually from Board members or collectively as a Board. He pointed out that if comments are not made then the right to object is forfeited. Mr. Hobson noted the deadline for comments is March 20, 2017.

Discussion ensued with Mr. John Heissenbuttel, CalAm Team Member, addressing the Board and encouraging their support of the project which is a key component of the High Country Community Wildfire Protection Plan that the Board directed and provided funds to the Amador Fire Safe Council to develop. Mr. Heissenbuttel stated he feels strongly that a comment letter should be submitted by the Board of Supervisors so that if any objections are heard later the County will have a seat at the table. Mr. Heissenbuttel offered to draft the letter for approval by the Board at its next meeting.

<u>ACTION</u>: Consensus of the Board to allow Mr. John Heissenbuttel and the CalAm team to draft a comment letter relative to the Environmental Assessment for the Panther Fuels Reduction and Forest Health Project and bring back to the Board for approval on March 14, 2017.

Supervisor Oneto returned to the Board Meeting at this time and was present for the remainder of items heard.

**Community Development Agency**: Update by Mr. Aaron Brusatori, Community Development Director, regarding the recent storms and damages to County roadways and necessary ongoing road closures.

Mr. Aaron Brusatori, Community Development Agency Director, addressed the Board and provided a brief update relative to recent storms and damages. He stated damage to County roadways associated with the storms January 3-12 has been estimated at approximately 1,716,670.00 dollars with a significant portion of damage being associated to super saturation of the sub grades of roads and degradation of the roads subsequent to receding water. Mr. Brusatori also noted the January 18-23 storms resulted in approximately \$22,000.00 in damage and the February storms have been estimated at 2,066,000.00 but continues to rise as additional damages are assessed. He stated as the Board is aware, significant damage resulted on Shakeridge Road and is currently estimated at approximately 1.4 million dollars. Geo technical engineers are continuing to assess damage and provide reports as they become available. Shakeridge Road will remain closed until repaired possibly early to mid-Summer. Pioneer Creek Road is currently down to one lane traffic and an estimated \$600,000 in damage at this time.

General Services Administration: Discussion and possible action relative to a report by the Projects Ad Hoc Committee regarding prioritizing of projects and General Service Administration staffing levels.

Mr. Jon Hopkins, General Services Director, addressed the Board and reviewed a summary memorandum which is hereby incorporated into these minutes as though set forth in full. He stated on January 24, 2007 the Board discussed outstanding Capital Improvement Projects, Special Projects and Maintenance Projects making one funding commitment of \$50,000.00 to make repairs to the Pine Grove Town Hall referring all other matters to the Projects Adhoc Committee. He stated on February 23, 2007 the CAO, Staff and the Committee met to discuss project priorities, funding and staffing. He reviewed a list of GSA projects (included in the memo) the Board approved using one time monies during the Budget process.
