## **CERTIFICATE OF MERGER INFORMATION**

The Board of Supervisors passed Ordinance No. 854, Amador County Code No. 17.94.040 whereby a parcel of land may be merged by a Certificate of Merger.

The owner of contiguous parcels or units of land shall be the only party who may request a Certificate of Merger.

The Certificate of Merger will be submitted to the Board of Supervisors who will set a Public Hearing date. The Public Hearing takes about 45 days because of the notification requirements and agenda scheduling. The Public Hearing Notice will be posted in the field, advertised in the local newspaper and mailed to adjacent property owners. The Board of Supervisors, finding no objection at the public hearing, may approve the Certificate of Merger and transmit a resolution and the certificate to the Amador County Recorder for recording.
