This memo and the attached documents request that the Board authorize the Chair to sign the document approving a 5 % (per cent) stipend be authorized for the class of Utilization and Quality Management Coordinator, effective May 1, 2017.

This stipend has been discussed with Local 1021 SEIU, who has given signed concurrence (see attached). The position audits outpatient, crisis intervention and case management medical records to determine eligibility for services, medical necessity, and Medi-Cal compliance; ensures optimal reimbursement from Medicare, Medi-Cal, and other payors of these services; conducts quality improvement studies; provides narrative and statistical analyses of audits; orients and trains clinical staff on documentation requirements and/or arranges for appropriate instruction.

The approval of the stipend, which would be for this single position class, would enable the Health and Human Services Department to approve the stipend when an incumbent had appropriate clinical licensing. When an incumbent has the clinical licensing, a higher percentage reimbursement is possible under the claim for State reimbursement. This higher level of claim would save County general fund costs.

The consequence of approving this requested action will be to recognize the qualified licensed staff and enable a higher level of claiming for services.

If not approved, the ability to recognize licensure and claim accordingly would not be possible.
