# Minutes of Homeless Steering Committee Meeting 2-22-18

# 1. Homelessness Needs Assessment

The steering committee considered undertaking a Needs Assessment study, which would require hiring an outside consultant and going through the formal process that would take several months. Due to the time and potential cost the members felt that it was more important to develop our own strategies for now based on the group's observations and experience. However, it was acknowledged that a Needs Assessment will be needed when applying for grant funding.

Nichol Mulford, from Victory Village, suggested that we could use the Needs Assessment from the Continuum of Care (CoC) study already put together for the tricounty region. She said she would look into it and report back to the committee at the next meeting.

## 2. Homeless Housing

Mayor Gonsalves and Jackson City Council member Bob Stinson told the group that preliminary discussions had occurred with a property owner about a possible location of a shelter facility. Due to the early stages of discussions no details were provided to the committee.

# 3. PIT Count vs. Alternative Data Sources for Counting the Homeless

Due to the discrepancies between the 2017 PIT count and CalFresh data furnished by the County Health & Human Services department, it was discussed whether or not another PIT count during the summer months should be performed. It was decided that there was value in having such an assessment so we are looking into funding for it. The estimated cost for the count is \$10k.

# 4. Homeless Workshop

I briefly shared with the group that Chairwoman Morgan wanted a workshop on homelessness to be an agenda item before the Amador County Board of Supervisors at the March 27<sup>th</sup> Board of Supervisors meeting. At present that workshop is being set up.

# 5. Mission Statement, Goals & Reasons why

We re-hashed our goals and mission statement.

**Mission Statement:** 

Our mission is to compassionately serve the homeless; identifying needs and gaps in services in order to efficiently address homelessness in our county.

#### Goals:

Develop a comprehensive understanding of homeless issues in Amador County

- Developing awareness of and coordination amongst all active participating agencies & groups in the area
- Identify unmet needs for the homeless and the provider agencies
- Make recommendations for short term and long term solutions to problems
- Identify necessary funding sources or means of accomplishing goals
- Create a document describing Amador's homeless situation and recommendations
- Work to implement recommendations and improve the situation in a measurable way

#### Reasons:

- Impact to merchants
- Substance abuse (alcohol, opiate, and methamphetamine)
- Used needles in parks and school yards
- Using library as day shelter
- Making parks unusable
- Public health issues in make shift camps
- Crime
- Situation appears to be getting worse
- Compassion



### 8. Speakers

Homeless Issues in Jackson – Sgt. Mynderup (JPD)

Sgt. Mynderup provided his first hand experiences with the homeless community in the Jackson. He indicated it would get much worse before it would get better.

• Overview of Sierra Wind – Katrina Ozier

Katrina provided a brief overview of the services that Sierra Wind provides the homeless community primarily in and around the Jackson area. Sierra Wind provides a hot meal 5 days a week to anyone, clothing, phone service, couciling, and more.

• Community Outreach – Tyx Pulskamp

Txy Pulskamp shared with the members his own personal outreach to homeless people in the County. Feedback from his conversations included the need for persons with a car to be able to park and sleep overnight in a location with bathroom facilities.

In addition Tyx said he and Trina and Trixie, from Sierra Wind, will be handing out backpacks containing water, sunscreen, toiletries, etc at a booth at Dandelion Days in Jackson on March 17<sup>th</sup> & 18<sup>th</sup>.
