7.a. Public Hearing – Appeal of the Planning Commission's interpretation of the Zoning Ordinance that the existing operations of "The Hideout at Kirkwood" are not consistent with the Permitted or Conditional Uses of the "R1A," Single-Family Residential & Agricultural district.
