*Section 54954.2 (b) allows for the Administrative Committee to recommend action on a matter not on the posted agenda under the following circumstances:

Notwithstanding subdivision (a), the legislative body may make recommendations on items of business not appearing on the posted agenda under any of the conditions stated below. Prior to discussion any item pursuant to this subdivision, the legislative body shall publicly identify the item.

(1) Upon a determination by a majority vote of the legislative body that an emergency situation exists, as defined in Section 54956.5.

(2) Upon a determination by a 2/3 vote of the members of the legislative body present at the meeting, or, if less than 2/3 of the members are present, a unanimous vote of those members present, that there is a need to take immediate action and that the need for action came to the attention of the local agency subsequent to the agenda being posted as specified in subdivision (a).
