1. Public Comment

2. HEAP & CESH Funds

The Homeless Emergency Aid Program (HEAP) and California Emergency Solution and Housing program (CESH) are specific set of funding opportunities from the State of California which can be used for various housing and shelter options for the homeless in various jurisdictions.

The Central Sierra Continuum of Care (COC) which is comprised of Amador, Calaveras, Mariposa, and Tuolumne Counties will be receiving roughly \$1,273,314 and \$562,512 in HEAP and CESH funding respectively in the near term. (Denise Cloward – ATCAA)

4. Amador Transit report on unmet transportation needs

On Thursday December 6, 2018 Amador Transit (AT) will be presenting a report that describes unmet transportation needs in the county.

The process used to determine unmet involves 4 key components:

- 1) Soliciting testimony on unmet transit needs that may exist in Amador County
- 2) Analyzing transit needs in accordance with adopted definitions of "unmet transit needs" and "reasonable to meet" criteria
- 3) Consultation with the Social Services Transportation Advisory County (SSTAC)
- 4) Adoption of a finding regarding unmet transit needs that may be reasonable to meet for implementation in the next fiscal year
