7. PINE GROVE COMMUNITY SERVICES DISTRICT - SERVICE AREA ANNEXATION, RESOLUTION #2019-15, LAFCO PROJECT #324, (public hearing)

Annexation of 21 parcels in various locations contiguous to district boundaries & historically receiving water service from the district; no new service connections to be added. CEQA Statutory Exemption §15319(b), annexation of existing facilities and exempt lots, and no possibility that the project could have a negative effect on the environment.

June 20, 2019

## 1. Call to Order, Pledge of Allegiance & Roll Call

The June 20, 2019, meeting of the Amador Local Agency Formation Commission (LAFCO), held at the County Administration Center, 810 Court Street, Jackson, California, was called to order by Vice Chairman Vinciguerra at 6:02 p.m.

## 2. Roll Call

## Approval of Agenda for June 20, 2019

**Motion**: It was moved by Commissioner Colburn, seconded by Commissioner Atlan, and carried unanimously to approve the agenda as submitted.

## 4. Approval of the Minutes of May 16, 2019

**Motion**: It was moved by Commissioner Atlan, seconded by Commissioner Colburn, and carried unanimously to approve the Minutes for May 16, 2019, as submitted.

## 5. Approval of Claims to June 20, 2019

**Motion**: It was moved by Commissioner Colburn, seconded by Commissioner Atlan, and carried unanimously to approve the Approval of Claims – Meeting Final, as submitted.

## 6. Public Forum – Public Comment

There was no public comment.

# 7. Dissolution of County Service Area #7; Resolution #2019-11, LAFCO Project #312

Vice Chairman Vinciguerra opened the Public Hearing.



Executive Officer Chamberlain reported that the Notice of Exemption for this project had been filed in May, and that there is no exchange of property tax and this item is on the Board of Supervisors' agenda for June 25. She reiterated that this is a mandatory dissolution as it was on the list of inactive districts sent out by the State Controller's office. Ms. Chamberlain added that a 1/8-page ad had been placed in the Ledger Dispatch in April in lieu of mailed notice.

In answer to a question from Commissioner Colburn, Ms. Chamberlain responded that the district had originally been set up for the purpose of providing solid waste disposal service, but that an assessment had not been approved so the district never performed any function.

There was no public comment.

**Motion:** It was moved by Commissioner Atlan, seconded by Commissioner Colburn, and carried unanimously to approve Resolution #2019-11 as presented, with direction to staff to complete the necessary filings and transmittals for the dissolution.

# 8. <u>Final Municipal Service Review (MSR) 2019 Update, Lockwood Fire Protection District;</u> Resolution #2019-12; LAFCO Project #311 (public hearing)

Executive Officer Chamberlain stated that this is the final version of the Draft MSR presented at the May meeting, and that it includes the revisions received from the District. She added that the project is exempt from CEQA under sections 21102 and 21150 of the Public Resources Code.

There was no public comment.

**Motion:** It was moved by Commissioner Atlan, seconded by Commissioner Colburn, and carried unanimously to approve Resolution #2019-12 as presented, and to give staff direction to file a Notice of Exemption.

# 9. <u>Final Municipal Service Review (MSR) 2019 Update, Sunset Heights Community Service</u> <u>District; Resolution #2019-13; LAFCO Project #313 (public hearing)</u>

Clerk Mees reported that this is the final version of the Draft MSR presented at the May meeting, and that it includes the revisions received from the District. She added that additional clarifications had been received from the District since the packet had been distributed, that none were significantly substantive, and that those corrections were in the hand-outs presented at the dais prior to the meeting. Ms. Mees stated that these changes would appear in the final version of the MSR if approved by the Commission. She also reported that the boundaries have recently been verified according to recorded maps.

Executive Officer Chamberlain added that she wished to thank the three District Board Members in the audience for their active cooperation and participation in preparing this MSR. Vice Chairman Vinciguerra stated that the Commission appreciated District boards that cared enough to be involved in the MSR process. District Board Member Chuck Lowrie said their board appreciated the work LAFCO staff has done.

**Motion:** It was moved by Commissioner Colburn, seconded by Commissioner Atlan, and carried unanimously to adopt Resolution #2019-13 as presented, including the additional changes presented at the meeting.



# 10. Public Review Draft Municipal Service Review (MSR) 2019 Update, Pine Acres Community Service District; LAFCO Project #314 (public hearing)

Clerk Mees briefly reviewed the information in the packet memo, and explained the various road zones and fee structures of Pine Acres CSD. She reported that the two most important issues for the District currently are that they have no General Manager and that there are no written policies governing how property owners can join or leave a road improvement zone, or create a new one.

Executive Officer Chamberlain added that the attached map showed the recently verified boundaries of the District, which included a section that had historically not been shown on maps of the District. Ms. Mees added that mapping was currently being done to show which parcels are assessed which fees, and which parcels within the District are not currently being served by the District.

There was no public comment.

Motion: It was moved by Commissioner Colburn, seconded by Commissioner Atlan, and carried unanimously to circulate the Draft MSR for Pine Acres CSD for comment.

# 11. Sphere of Influence for Ridgewood Acres Community Service District; LAFCO Project #307; Resolution #2019-03 (hearing continued from January 17, 2019); no written materials

Executive Officer Chamberlain stated that Ridgewood Acres was currently having a meeting in the County building regarding whether to privatize their road maintenance, and she therefore requested the hearing be continued to August as she expected a resolution of the District's continued existence as a CSD in the near future.

By consensus, the Commission continued this item to the August meeting.

## 12. Other Business, Reports

- a. Correspondence Executive Officer Chamberlain reported that, in the pass-around binder, there was a letter of thanks from CALAFCO for Amador staff's attendance at the annual staff workshop.
- b. Commissioner Announcements none.
- c. Executive Officers Report none.
- d. Legislation Update Ms. Chamberlain stated that she had not been able to obtain a legislative update from the CALAFCO website. She did report that all bills previously discussed at Commission meetings were still in various stages in the Legislature, but that the annual omnibus bill was now going to the Governor and Amador LAFCO was sending a letter to his office stating support for his signing it.
- e. Project Status Report Ms. Chamberlain reported that there is some pre-application discussion regarding a nine-acre-parcel attachment on the border of Plymouth. She also stated that LAFCO Project #301 regarding City of Sutter Creek is currently being held up due to some title issues; that the final documents for the Dissolution of CSA #3 have been sent to the Board of Equalization; and that the documents for the Dissolution of CSA #7 will also soon



be completed and sent to the BoE. Ms. Chamberlain commented that the new legislation regarding dissolution of inactive districts has really streamlined the process.

# 13. Adjournment

By consensus of the Commission, the July 18, 2019, meeting is cancelled and the next regular LAFCO meeting is scheduled for August 15, 2019. Vice Chairman Vinciguerra adjourned the meeting at 6:33 p.m.

# **DESCRIPTION OF PROJECT**

This proposal for annexation consists of 21 parcels, which are currently receiving service in various locations around the district periphery. The project consists of the following parcels:

The annexation is made by resolution of Pine Grove Community Services District (PGCSD). The proposal is a boundary clean-up effort and will bring into the district all parcels where the district extended water service in the past without annexing them prior to initiating service. Notice of the annexation and hearing was individually mailed by LAFCO to registered voters and landowners. The notice of hearing was published in the Ledger Dispatch.

### **LOCATION**

The areas proposed for annexation are in various locations as shown in the attached descriptive map. The parcels are adjacent and contiguous to Pine Grove CSD.

## **PURPOSE**

The proposal will clean up the boundary/service area mismatch that was created during a period in the past when the district believed that any parcels within the sphere of influence were allowed to receive service without additional annexation proceedings. The proposal will complete annexation for each parcel, will allow the residents to participate in district elections and be subject to all the rights and privileges as citizens of the district.

### **BACKROUND** and LAND USE

The District has desired to annex the parcels since at least 2009 when they realized that the district's internal proceedings to serve were not sufficient to legally annex the properties.

The district provides service to all parcels, has infrastructure in place for the service and has been collecting user rates sufficient for the costs of the service. All service connection fees and participation fees were paid at the time service was extended. One parcel is inactive. A meter box was installed in the past in anticipation of an active connection going in, but water has not yet been sold to this account. No new service will result from the annexation, and no new development is planned.

Pine Grove is an identified Town Center in the County General Plan. Land uses include developed residential properties and one connection to an existing nursery business. No change in services or service demand will result from this annexation.

#### **CEQA**

Staff has reviewed the proposal and found the annexation to be exempt under Section 15319(b), annexation of existing facilities and lots for exempt facilities. The Notice of Exemption is attached.

## **DETERMINATIONS**

The Commission should review the factors summarized above, then make its own determinations regarding the project. Staff recommends the following determinations based on project research, state law and local policies:

- 1. The subject territory is "inhabited" per Government Code §54046. Application for this reorganization is made subject to Government Code §56650 et. seq. by resolution of an affected district. All landowners (100%) have not consented to the reorganization.
- 2. The annexation is consistent with the Sphere of Influence of the Pine Grove Community Services District and the property is contiguous to the existing district boundary.
- 3. The boundaries are definite and certain and conform to lines of ownership and parcel lines.
- 4. The annexation will provide a logical and orderly boundary and eliminate some parcels divided by district boundaries.
- 5. The annexation will not result in negative impacts to the cost and adequacy of service otherwise provided in the area, and is in the best interests of the affected area.
- 6. The annexation will not have an adverse effect on agriculture and open space lands, will not have an adverse effect on environmental justice, will not affect the county's ability to achieve its fair share of the regional housing needs and will not increase safety or fire

hazard risk.

7. The annexation is found to be exempt under Section 15319(b), Title 14, Article 19, Class 19 of the California Code of Regulations, annexation of lots containing existing facilities and lots for exempt facilities.

# **RECOMMENDATIONS**

Staff recommends that the Commission take the following actions:

- 1. Adopt Resolution #2019-15, making determinations, adding conditions and approving the Pine Grove Community Services District Service Area Annexation (LAFCO Project #324).
- 2. Direct the Executive Officer to prepare and file a Notice of Exemption pursuant to Title 14, Article 19, Class 19 of the California Code of Regulations.
- 3. Direct the Executive Officer to hold Conducting Authority proceedings in compliance with Resolution #2019-15, and Government Code Section 57000 et. seq.
- 4. Direct the executive officer to complete the necessary filings and transmittals as required by statute and policy.

# RESOLUTION MAKING DETERMINATIONS AND APPROVING THE PINE GROVE COMMUNITY SERVICES DISTRICT SERVICE AREA ANNEXATION (LAFCO Project #324)

WHEREAS, a resolution making application for the proposed annexation of certain territory in the County of Amador was heretofore filed with the Executive Officer of this Local Agency Formation Commission pursuant to the Cortese/Knox/Hertzberg Local Government Reorganization Act, commencing with Section §56000, et seq. of the Government Code; and

WHEREAS, the Executive Officer has examined the application documents and has accepted the proposal for filing; and

**WHEREAS**, the Executive Officer, pursuant to Government Code §56665 has reviewed this proposal and prepared a report including her recommendations, and has furnished a copy of this report to each person entitled to a copy; and

**WHEREAS**, notice of the proposal and its hearing was provided to landowners, registered voters, agencies and all persons requesting notice; and

**WHEREAS**, LAFCO, as lead agency, has reviewed the project and finds that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), under Section 15319(b) of the California Code of Regulations because it consists of annexation of lots containing existing facilities and lots for exempt facilities; and

**WHEREAS**, the Commission has received, heard, discussed and considered all oral and written information related to the proposal, including but not limited to, comments and objections, the Executive Officer's report and recommendation, the environmental review, plans for providing service, spheres of influence and applicable General plans; and

**WHEREAS**, the Commission does hereby make the following determinations regarding the proposal:

- 1. The subject territory is "inhabited" per Government Code §54046. Application for this reorganization is made subject to Government Code §56650 et. seq. by resolution of the subject agency.
- 2. The annexation is consistent with the Sphere of Influence of the Pine Grove Community Services District as adopted March 20, 2019, and the parcels to be annexed are contiguous to the existing district boundary.
- 3. The boundaries of the annexation are definite and certain and conform to lines of ownership and parcel lines.
- 4. The annexation will provide a logical and orderly boundary and eliminate some parcels divided by district boundaries.



- 5. The annexation will not result in negative impacts to the cost and adequacy of service otherwise provided in the area, and is in the best interests of the affected area.
- 6. The annexation will not have an adverse effect on agriculture and open space lands, will not have an adverse effect on environmental justice, will not affect the county's ability to achieve its fair share of the regional housing needs and will not increase safety risks or fire hazard risk.
- 7. The annexation is found to be exempt under Section 15319(b), Title 14, Article 19, Class 19 of the California Code of Regulations, annexation of lots containing existing facilities and lots for exempt facilities.

# NOW, THEREFORE, BE IT HEREBY RESOLVED, DETERMINED AND ORDERED as follows:

- 1. The annexation is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), under Section 15319(b) of the California Code of Regulations and consists of annexation of 21 parcels where water service has historically been provided by the district and service is currently in place.



### **DESCRIPTION & BACKGROUND**

Government Code requires the commission to adopt and update as needed, the spheres of influence of each district and city every five years. The Sunset Heights Community Services District (SHCWD) sphere of influence was adopted in 2008, affirmed in 2014 (Resolution #2014-13). It includes all the parcels within the district with the exception of nine parcels which historically have not been charged an assessment and have not received maintenance services.

The 2019 Municipal Services Review (MSR) review for Sunset Heights Community Services District updated the status of SHCSD and was reviewed by the commission in June 2019. Determinations regarding the district were made in Resolution #2019-13. Those determinations are consistent with reducing the existing sphere of influence and encouraging the district to detach the properties where service has not been provided. On June 14, 2019, the district board decided to request that LAFCO remove the five parcels along Ridge Road from the current sphere of influence at this time, and on June 28, 2019, the district board decided to request that LAFCO remove the four parcels on Sunrise Court from the current sphere of influence at this time, and understands that they can request a detachment of those parcels from the district boundary in the future.

The analysis and complete profile for the district is contained in the 2019 Municipal Services Review and is made a part of the record of this action by reference.

## **CEQA**

LAFCO is the lead agency for the project. The Executive Officer has reviewed the proposal and determined that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), Section 15061(b)(3) of the Public Resources Code, in that there is no change in services or service demand and no possibility that the project could have a negative effect on the environment (Notice of Exemption attached).

# **RECOMMENDATIONS**

Staff recommends that the Commission take the following actions:

- 1. Hold the public hearing and determine whether the previously adopted sphere of influence should be amended for Sunset Heights Community Services District.
- 2. Find that the project is exempt from the provisions of CEQA pursuant to Section 15061(b)(3) and direct staff to prepare a Notice of Exemption pursuant the California Code of Regulations.
- 3. Adopt Resolution #2019-16, making determinations and amending the existing sphere of influence of the Sunset Heights Community Services District.
- 4. Direct staff to complete the necessary filings and transmittals as required by law.

WHEREAS, at the times and in the form and manner required by law, the Executive Officer has given notice of the hearing by this Commission; and upon the date, time and place specified in said notice of hearing and in any order or orders containing such hearing, the Commission has received, heard, discussed and considered all oral and written testimony related to the Sphere of Influence, including but not limited to comments, objections, the Executive Officer's written and oral report and recommendation, the environmental determination, the Municipal Services Review, previously adopted spheres of influence and proposed amendment to the historic sphere of influence;

NOW, THEREFORE, BE IT HEREBY RESOLVED, DETERMINED AND ORDERED as follows:





### BACKGROUND:

The Final Municipal Service Review (MSR) for Pine Acres Community Services District is attached. This MSR was undertaken at this time to comply with the statutory requirement of updating the MSR once every five years.

### DISTRICT HISTORY:

The district was formed in 1964 as an independent special district. The District was originally created to provide street and roadway improvements, street lighting, fire protection and water service, as well as several other services that were never initiated. Fire service was transferred to Amador Fire Protection District in 1994, and water service was transferred to Amador Water Agency in 1995. The District currently provides only street maintenance and street lighting. Pine Acres Community Services District (PACSD) is located approximately one mile southeast of Pine Grove. The boundary begins near State Route 88 at the intersection of Maudern Lane and Tabeaud Road, and stretches southeasterly to along Clinton Road.

The District currently encompasses approximately 841 acres, consisting of 493 assessed parcels. The Wildwood Subdivision is within District boundaries, but is only assessed an administration fee; the roads in the subdivision are maintained by the County. There are other parcels within the District which maintain their own small road or court, and are not assessed by the District. The current boundary exists after one annexation in 1969. PACSD has a coterminous sphere of influence, most recently affirmed in 2014. The District boundaries were reviewed and verified based on recorded legal description. There are differences between the verified boundaries and the historically accepted boundaries.

### DISCUSSION:

The attached MSR describes the district and its services. A volunteer District Board of five members performs management and administration of the District, which includes

three distinct road improvement zones. Each zone is directed by a road committee consisting of volunteer property owners within the zone. Each committee determines needed improvements for its zone and solicits bids for contractors, subject to PACSD Board approval. Services consist primarily of road maintenance and snow plowing, with the work being done by contractors.

The District tracks its finances through a single general fund held by the County Auditor, with separate cash accounts existing for each of the three road zones, as well as one for administration and one for snow removal. The administration account, which would cover any repairs to the office building owned by the District as well as ongoing office expenses, is currently underfunded. An independent audited financial statement is prepared every two years.

The District board, meets monthly, posts agendas, has regular financial reviews, and has the required insurance. Although the board and its zone committees actively manage maintenance service and repairs through hired contractors, it does not have a General Manager as required by state law. This finding was made in the 2014 MSR, and has still not been resolved.

So far PACSD has been able to maintain its plan of road maintenance and repaving, but the Board is concerned about the impact of escalating oil costs as they affect paving costs.

Identification by map of the assessed and unassessed parcels, as well as which roads are maintained and not maintained, needs to be undertaken by the district. Currently this information is not available in any easily identifiable way. In addition, a policy for amending the road zones needs to be established to allow currently privately maintained roads in the District to be allowed to become part of one of the zones, and then be assessed, if the property owners along those roads so desire. The District currently has no bylaws or policies.

#### STAFF RECOMMENDATIONS:

- 1. Find that the Pine Acres Community Service District Municipal Service Review of 2019 is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21102 and 21150 in that it is a descriptive and planning study for possible future action for which funding has not been committed.
- 2. Adopt Resolution #2019-17, finding the MSR adequate and complete and making determinations regarding the district.

# SUMMARY OF DETERMINATIONS AND FINDINGS

# Growth and population projections

❖ There has been no recent growth in the Pine Acres Community Services District (PACSD), and there are few open parcels for potential development within District bounds. While population is unlikely to change within the district, gradual population growth in surrounding areas may impact roads and maintenance services provided by the district.

# The Location and Characteristics of Disadvantaged Unincorporated Communities Within or Contiguous to the Agency's SOI

❖ The District does not provide services related to wastewater, municipal and industrial water, or structural fire protection; therefore, requirements regarding identification of DUCs is not applicable to this review.

# Present and planned capacity of public facilities and adequacy of public services, including infrastructure needs and deficiencies

- Present and planned capacity of public facilities is sufficient, and service provision appears adequate, as the District has plans to resurface some paved roads (in the road improvement zones) in FY 19.
- ❖ All paved roads are reported to be in excellent condition, and the District did not report any infrastructure needs or deficiencies.
- Some roads not in the improvement zones are not paved, as the homeowners in that zone have chosen not to pay for paving.
- The roads in the Wildwood subdivision within district boundaries are paved, but are maintained by the County and are not the responsibility of the District.
- ❖ The District should write policies governing the determination of which roads are maintained and assessed, as well as how roads already within the district can become part of one of the Road Maintenance Zones if the property owners wish to have the District maintain their road now or in the future.
- ❖ The District should create and maintain a listing and maps of which roads are maintained and which parcels are assessed for which fees.

# Financial ability of agencies to provide services

❖ As long as oil prices do not increase significantly, the current financing level is adequate to deliver road maintenance services; however, the District reports that it lacks the resources to hire a paid general manger as required by law.



- In the absence of long range planning, and clear reserves for future cost increases and policies for contingencies, road maintenance could be adversely affected.
- Funding in the administration account has been less than expenses in that account in recent years. Therefore, the District may want to consider increasing the annual \$12 assessment or modifying its budget to manage this issue.

# Status of, and opportunities for, shared facilities

❖ The District does not presently share facilities, and no such opportunities were identified as feasible in the course of this study. The District should continue providing cooperative uses of its office building for community or other uses.

# Accountability for community service needs, including governmental structure and operational efficiencies

- The District lacks a general manager, as required by law, to implement board policies. In order for the District to comply with State legal requirements, it is recommended that PACSD appoint a volunteer general manager.
- No government structure options are apparent, as there are no other road maintenance districts adjacent to PACSD. District maintained roads do not meet the design standards to be accepted into the County's public road system.
- The District transmits terms of office for board members and annual Form 700s at the request of the County Elections Office, and should continue to do so.
- The District has no bylaws, policies or procedures as may be required by law. These would prudently minimize risks and improve the overall efficiency of the district. Copies of appropriate bylaws from similar local agencies are available to PACSD as samples. The District should consider the benefits of establishing relationships with similar agencies in Amador County to enhance improve performance and efficiency.
- There is no formal complaint process and no procedure for handling Public Records Act requests. While these may have been handled informally in the past, reliable procedures to comply with state laws will improve District accountability to its citizens and transparency to the public.
- ❖ The District should ensure that its Board Members and the General Manager, once appointed, complete ethics and sexual harassment training, as well as training to comply with the Brown Act and Public Records Act.
- The District should have a written policy concerning legal counsel should they require it. They should also consider putting an attorney on retainer, or at least having an attorney who has agreed to serve as their counsel if the District ever has the need for one.
- The District should consider joining California Special Districts Association or another similar organization. This could ensure that it stays current with changes in state law and requirements for districts.

❖ Due to the passage of SB929, the District will need to set up and maintain a website that complies with the requirements of the new legislation, as well as previously enacted legislation, by January 1, 2020. The Board is considering its options, including using the County website, which has been made available to help provide a platform which small districts in the County could utilize at a minimal cost.



# PINE ACRES COMMUNITY SERVICES DISTRICT

Pine Acres Community Services District (PACSD) provides maintenance of private roads (including snow removal) and street lighting services.

# AGENCY OVERVIEW

# Background

PACSD was formed on November 6, 1964, as an independent special district.¹ PACSD was originally formed to provide street and roadway improvements, police protection, mosquito abatement, street lighting, recreation, fire protection, domestic water supply, and sewage and garbage disposal. The District initiated street maintenance, street lighting, fire protection, and retail water services at the time of formation; however, in 1994 and 1995 the District halted fire protection and water services, respectively, and these services were assumed by the Amador Fire Protection District and Amador Water Agency, respectively. Police protection, mosquito abatement and sewage and garbage disposal services were never implemented by the District and are not active powers.

The principal act that governs the District is the Community Services District Law.<sup>2</sup> CSDs may potentially provide a wide array of services, including water supply, wastewater, solid waste; police and fire protection; street lighting and landscaping; airport, recreation and parks; mosquito abatement; library services; street maintenance and drainage services; ambulance service; utility undergrounding; transportation; graffiti abatement; flood protection; weed abatement; and hydroelectric power; as well as various other services. Since 2005, CSDs are required to gain LAFCO approval to add or divest those services permitted by the principal act (i.e., latent powers).<sup>3</sup>

The functions and classes of services offered by PACSD, which were authorized by LAFCO in January 2006 and reaffirmed in 2009, are as follows:4

- Acquire, construct, improve, maintain, and operate street lighting and landscaping on public property, public rights-of-way, and public easements.
- Acquire, construct, improve, and maintain streets, roads, rights-of-way, bridges, culverts, drains, curbs, gutters, sidewalks, and any incidental works.

In 2009, LAFCO also recognized that PACSD could not provide oversight and maintenance of Covenants, Codes and Restrictions (CC&Rs) in the Pine Acres subdivisions, as these services are not authorized in the District's enabling act. The District reports that it no longer

provides oversight and maintenance of CC&Rs, and that enforcement is done through County Code Enforcement when possible.

## **Boundary**

PACSD's boundary is located approximately one mile southeast of the community of Pine Grove in the vicinity of Pine Grove Tabeaud Road, east of Mt. Zion. The bounds begin near SR 88 (at the intersection of Maudern Lane and Pine Grove Tabeaud Road) and stretches southeasterly to along Clinton Bar Road. The District covers approximately 841 acres, or approximately 1.3 square miles.

LAFCO records indicate there has been one completed annexation to the District. The Rodman annexation occurred in 1969 and included an unknown amount of land.<sup>5</sup> A second annexation, the Betz, et al., annexation, was attempted in 1979. The annexation was approved by LAFCO<sup>6</sup>; however, there are no completion documents or any record of Conducting Authority proceedings and the area is not within the verified boundaries or election precincts.

# Sphere of Influence

LAFCO records of PACSD's sphere history are not clear. The original SOI was adopted in April 1976, but no map is attached to the resolution in the LAFCO archives. In 2009, LAFCO conducted boundary research through recorded documents and subsequently affirmed a coterminous SOI for the District. The coterminous SOI was affirmed in 2014.

Although the Wildwood Subdivision is within the District's boundaries and Sphere of Influence, road maintenance and snow removal in this area are performed by the County. The District collects an annual Administrative Assessment.

# Local Accountability and Governance

A five-member board of directors who are to be elected at-large to four-year terms governs PACSD. All board members since 1994 have been nominated by the District and appointed by the Board of Supervisors in lieu of an election, as each of the positions were uncontested. See Figure 1 for information on individual board members and term expirations.

The District does not have a website, but currently informs constituents through an annual newsletter and occasional events such as neighborhood potlucks. They are aware, however, of their need to have a website by January 1, 2010, and have been looking at options. The programs they have looked at so far are not within their budget. LAFCO recently informed them, however, of Amador County's offer to host CSD websites on the County website at a reasonable cost, and the Board will be discussing this at their next board meeting.

Agendas are posted three days in advance of their bi-monthly meetings in a protected area on the outside of their office on Tabeaud Road.

The District reported that it has had no Brown Act violations in recent history.

The District does not have written by laws or policies, nor does it have any policies regarding administration, operation of the District, or handling of fiscal issues. These are required by statute. $^{10}$ 

Form 700 Financial Statements have been completed by all Board Members and are on file at the County Elections Office. The District does not have a separate Conflict of Interest Code. The District transmits terms of office for board members and annual Form 700s at the request of the County Elections Office.
