2. <u>Up- Tick in the Homelessness Around the Area?</u>

During the normal schedule of meeting that I attend as Supervisor there have been an increase in the number of specific incidents of homeless disturbances being observed and reported in the County. Specific incidents include:

- At the July 2019 ACRA Board meeting it was noted by one of the Program Directors
 that there are no tables available in Detert park for the children attending summer
 classes to eat their lunch
- People routinely camp out under the Public Library in Jackson
- Report by the Historical Society that a homeless person was living under the front porch of the County Museum (Spring 2019)
- In a separate indecent the Historical Society said a Homeless person lite a fire and burned a hole in a picnic table at the County Museum (June 2019)
- There has been an individual camped out by Pine Grove Market since April or May of 2019 under the tree in the vacant lot next door
- In July 2019 I met an individual in Pine Grove Park who was homeless while visiting the Farmers Market.
