# Tuesday, March 3, 2020 Voter Instructions and Information Pamphlet INSTRUCTIONS TO VOTERS

#### HOW TO VOTE YOUR BALLOT:

- Remove the enclosed official ballot.
- Use a black ink pen only to mark your votes.
- To vote, completely fill in the oval () to the left of any candidate.
- Do not vote for more than the authorized number of candidates.
- To vote for a write-in candidate whose name does not appear on the ballot, write the person's name in the blank space provided directly below the names of the other candidates for the office. Completely fill in the oval (
  ) to the left of the name using a black ink pen ONLY.

#### HOW TO RETURN YOUR BALLOT:

- Amador County is now 100% Vote-by-mail. Every voter will receive a ballot in the mail.
- The ballot in this packet is your ballot, not a sample ballot. Vote this ballot according to the above instructions.
- Place your voted ballot inside the return envelope. Be sure the envelope is sealed and signed.
- Return your ballot 1 of 3 ways.
  - Postage paid mail.
    - You may also return your ballot at our **24-hour ballot drop-box** behind the County Administration Building, or any of our **6 additional drop-boxes** located throughout the county.
    - o Lastly, you may bring your ballot to any of our **3 vote centers**.

# Vote center and drop-box locations and hours are on the back of this guide, and online at <u>www.amador.vote</u>.

Your voted ballot must be **postmarked by Election Day and** received by the Elections Office by Friday, March 6 at 5 pm. It can be delivered on or before Election Day to the Elections Office, any drop-box, or any Vote Center; all ballots must be received by 8 PM on Election Day, **postage is not required**.

We will be happy to assist you if you have any questions. Our office is located at 810 Court Street, Jackson, CA. Telephone (209) 223-6465. Regular office hours: Monday-Friday 8:00 a.m. to 5:00 p.m. On Election Day, the office hours will be from 7:00 a.m. to 8:00 p.m.

# NOTE: You must sign the Identification/Return envelope in your own handwriting! If your ballot envelope is not signed, your vote will not be counted!

You no longer need to authorize a person to return your Vote By Mail ballot. You may now allow someone to return your ballot regardless of their relationship to you. Simply write their name in the box on the back of the return envelope and have them sign.

### ASSISTANCE TO THE VISUALLY, HEARING, OR SPEECH IMPAIRED

Amador County also has the ExpressVote Universal Marking Device for voters who are unable to view or personally mark the ballot. For your convenience, these devices are located at all Vote Centers.

### IF YOU SPOIL YOUR BALLOT

If you make a mistake, tear, or deface your ballot, return it to the Elections Office or any Vote Center and another ballot will be issued.

## How to vote in a primary election

All voters can vote in a primary election.

Voting for President depends on the party with which you are registered.

The primary election in March chooses the candidates who will run in the General Election in November. You may see three different types of primaries on your ballot.

The way each primary works depends on the office.

How to vote in the Presidential Primary

Six political parties are holding Presidential Primaries:

★ Democratic★ Republican

- ★ American Independent★ Green
- ★ Libertarian
- ★ Peace and Freedom

If you are registered with one of these parties, your ballot will include the candidates running for that party's nomination.

If you are registered with one political party, you **may not** vote a ballot for another political party.

You can only vote for the County Central Committees/County Councils if you are registered with that party.

If you are not registered with one of the six political parties, or if you registered Decline to State, Independent, or Nonpartisan, you are a **No Party Preference (NPP) Voter**.

Three parties allow NPP voters to vote in their presidential primary:

- Democratic
- American Independent
- Libertarian

If you want to vote in one of these party primaries, you must ask for that ballot. Otherwise, you will receive a Nonpartisan ballot that will not include the office of President.

Three parties allow only voters registered with their party to vote in their presidential primary:

- Republican
- Green
- Peace and Freedom

If you want to change your party registration before the primary, the last day to re-register to vote is February 17, 2020. Information is online at **www.amador.vote** and in the county Voter Information Guide.

### How to vote in the California Top-Two Primary

In a Top-Two Primary, you can cast your vote for any candidate.

- All candidates from all parties will be on the ballot for these contests.
- You don't have to be registered with a party to vote on these contests.
- You can vote for a candidate from any party.
- You can "write in" a candidate in the Primary Election.
- The two candidates with the most votes will appear on the General Election ballot even if they have the same party preference.

**Nonpartisan offices:** Judges, County Supervisor, and County offices are always open to all eligible voters.

### What does party preference mean?

Voters may either register with a political party preference or choose "none."

A candidate's party preference does not necessarily mean that they have that political party's support. The list of candidates who receive a party's official endorsement is in the county Voter Information Guide.



#### TOP TWO CANDIDATE OPEN PRIMARY

A Top Two Primary lets you vote for any candidate (for most races), even if you are not in the same political party. The top two candidates - the ones who receive the most votes in the primary -will be on the General Election ballot in November no matter what party they are from.

#### Top Two DOES NOT apply to elections for President, Party Central Committees, or County Offices

California law requires the following information be printed in this notice.

#### VOTER-NOMINATED OFFICES (State Offices; Senate, Assembly)

A candidate is the nominee of the people and not the official nominee of any party at either the primary or general election. A candidate shall have their party preference, or lack of party preference, stated on the ballot. Party designation is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated. In the county sample ballot booklet, parties may list the candidates for voter-nominated offices who have received the party's official endorsement. Any voter may vote for any candidate for a voter-nominated office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation.

#### NON PARTISAN OFFICES (Local Offices)

A candidate for nomination to a nonpartisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

The 2020 Census is closer than you think! Here's a quick review of what it is and why it's important that everyone is counted.

# What is it?

The census is a process of counting every person living in the Unites States. The first census took place in 1790. The U.S. Constitution mandates that everyone in the country be counted every 10 years.

# What is it used for?

**Representation:** Every 10 years, the results of the census are used to determine how many seats each state gets in the House of Representatives. This determines how many electoral college votes each state has as well.

**Money:** The results of the census also help with deciding the distribution of more than \$675 billion in federal funds and grants to be spent locally on schools, hospitals, roads, public works and other vital programs.

**Boundaries:** After every census, state officials redraw the boundaries of the congressional and state legislative districts in their states to account for change in population.

# Your privacy

Your privacy is protected. It's against the law for the Census Bureau to publicly release your responses in any way that could identify you or your household. By law, the Census Bureau cannot share your answers with any other government agency.

Be counted! 2020 will be easier than ever to participate in. In 2020, you will be able to respond to the census online.
