Dear Planning Commissioners,	
I am writing to request that both the public hearing and decision on the Blood Gulch event center permit be continued to the next available Planning Commission hearing after June 9.	
As you can see from the emails below, the 79-page staff report and mitigated negative declaration (attached) was not available until 5:15 pm on Thursday, June 4. This does not afford the public with sufficient time to provide researched and meaningful comments on the document. (CEQA Guidelines, sec. 15105, subd. (b) ["The public review period for a proposed negative declaration or mitigated negative declaration shall be not less than 20 days."] The 5 days available barely provides enough time for people to raise reasonable doubts or questions about the project. (I apologize in advance for submitting so many such questions next week.) It certainly does not give staff sufficient time to answer questions and resolve issues. The process works better when there is time for such constructive exchanges.	
While I realize that you will still hold the noticed public hearing on June 9, I am requesting that the public hearing be continued to a later date, rather than closed on June 9.
