Speed Concerns on Buena Vista Road: Mr. Mike Krisman, District II resident, took this time to present a signed petition from residents in the Buena Vista Road area who are concerned with excessive speed, noise and dust caused by vehicles traveling on Buena Vista Road. Mr. Krisman pointed out that a bull was killed approximately three weeks ago by a driver that was traveling at an unsafe speed. He continued by stating he and other residents are hopeful that presenting the petition will be a proactive measure and start the process of initiating a speed study or other research that needs to be completed prior to a reduced speed limit being posted. Mr. Krisman advised he has been in contact with the California Highway Patrol and understands that mitigation measures will have to be looked at and certain processes will need to be vetted before any action can be taken.

Mr. Bill May, District II resident, added to Mr. Krisman's concern by advising the Tribe has petitioned Alcohol Beverage Control to alter their current allowed hours to serve alcohol and has requested to be allowed to serve alcohol on the gaming floor which could prove to be a precarious situation when patrons are leaving the Casino and traveling on the roadways in the area.

Tree Mortality: Update on Tree Mortality mitigation activities by Tad Mason, TSS Consultants, Dr. Richard Harris, and Ed Struffenegger.

Mr. Tad Mason, TSS Consultants, and Dr. Richard Harris joined the meeting via ZOOM. Dr. Harris presented a brief Power Point presentation outlining the current status and projected future activities regarding Tree Mortality mitigation in the area. A complete copy of the presentation is hereby incorporated into these minutes as though set forth in full.

ACTION: Presentation only.

Limited Density Rural Dwelling-LD1032 (Hermann): Discussion and possible action relative to modifications to current LDRD agreement #LD1032 adopted by the Board on November 12, 2019.

Mr. Mike Israel, Community Development Director, addressed the Board and stated there is a section in Chapter 15.10 of County Code that states offering the property for sale indicates that presumed intent was present prior to obtaining the permits to build. However, the Community Development Director does have the ability to allow sale prior to the three year provision. Mr. Israel indicated he had concern with this particular situation as the property was listed for sale prior to the request coming to the County and he felt the demonstration of hardship could have been better supported. For those reasons he suggested the matter be brought to the Board for discussion and possible action.

Supervisor Forster stated although he was not contacted by the applicants regarding this issue, he knows them personally and agrees with the disclaimer of personal hardship in this situation and supports the request to modify the agreement and allow sale of the property within the three year limit.

Mr. Chris Hermann joined the meeting via ZOOM and explained the circumstances surrounding family hardship and requested approval to sell the property within the three year time frame outlined in the agreement.

<u>ACTION</u>: Direction given pursuant to the following motion.

<u>MOTION</u>: It was moved by Supervisor Forster, seconded by Supervisor Oneto and unanimously carried to authorize the owners of the subject property to sell prior to the three year period being exhausted due to extenuating circumstances related to family health situations.

General Services Administration: Discussion and possible action relative to new requirements being placed on Animal Control and a proposed new fee schedule for the Department to account for these additional costs.

Mr. Jon Hopkins, General Services Director, addressed the Board and summarized the staff memorandum relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, Ms. Kelly Reason, Animal Control Director, brought to his attention information regarding Senate Bill 573 that will be added to the Food and Agriculture code section 31108.3, effective January 1, 2021. This bill will require animal shelters and rescue groups to microchip all dogs and cats that are either adopted out of the shelter or returned to the owner after being impounded. The only exception to this would be if a veterinarian states the animal would be medically unfit or if the person either adopting the animal or reclaiming their own animal signs a statement stating that the cost of the microchipping would impose a financial hardship on them. Mr. Hopkins continued by stating the fee schedule before the Board today indicates an additional \$15.00 for adoption of dogs and cats. The \$15.00 is inclusive of staff time and the cost of the chip.

He stated staff further recommends this fee change to reflect the actual cost of the chip currently at \$5.00.

Discussion ensued with the following action being taken.

General Services Administration: Discussion and possible action relative to Bid Proposal 20-19-Reject all Proposals.

Mr. Jon Hopkins, General Services Director, addressed the Board and summarized the staff memorandum relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, he stated on October 15, 2020 at 1:30 p.m. the Amador County Invitations to Bid (ITB) 20-19 were received, opened and read publicly for the Purchase and Installation of two stand-by generator systems for the District Attorney's Office and Pioneer Park Veterans Hall. Bids received exceed the available funding with the exception of one bid received by Baran Electric (low bidder) who has requested to withdraw their bid. Baran Electric's bid amount compared to the other bid amounts is significantly lower. Mr. Hopkins stated staff determined Baran Electric did not respond appropriately and significantly underbid the project. In addition, the other bids received are cost prohibitive as proposed.

Ms. Carolyn Fregulia, ACRA Executive Director, presented the Annual Mitigation Fees Report for fiscal year 2019-2020, and the approved Five-Year Plan. She continued by pointing out that Recreation Mitigation Fees collected in Amador County are handled by the Amador County Recreation Agency. An annual report of how much was collected in each of the park service areas is necessary, along with any expenditures for capital improvements. Ms. Fregulia stated the Capital Improvement Plan that was updated in June of 2012 and the Five-Year Report on the Recreation Mitigation Fees approved by the Board of Supervisors on January 24, 2017 is also included in the Report.

Chairman Crew opened the Public Hearing at this time. Hearing no comment the following action was taken.

Resolution approving review of the Amador County Park and Recreation Capital Improvement Plan, the Annual Mitigation Fees Report for F/Y 2019-2020 and the approved Five-Year Plan

Administrative Agency: Discussion and possible action relative to a request by the California Forestry Association to join a coalition and intervene in support of the U.S. Fish and Wildlife Service in a lawsuit regarding a decision by the USWFS that listing the California Spotted Owl was not warranted under the Endangered Species Act.

Supervisor Forster introduced this item and summarized a background letter received from the California Forestry Association. Supervisor Forster stated the CFA is requesting participation in a coalition seeking to intervene in support of the U.S. Fish and Wildlife Serve in a lawsuit brought by Sierra Forest Legacy, Defenders of Wildlife, and the Center for Biological Diversity regarding a decision by the Service that listing the California Spotted Owl was not warranted under the Endangered Species Act.

Supervisor Axe took this time to summarize some points made by the Deputy Director of Fish and Wildlife in a summary of findings. He pointed out that while some conservation measures are in place, the main threat to the California Spotted Owl habitat is wildfire and being able to mitigate that through thinning of the forest in some cases would be to the benefit of the species.

Mr. John Heissenbuttel, Registered Professional Forester and Amador Fire Safe Council Member, joined the meeting via ZOOM. Mr. Heissenbuttel stated he has reviewed the background paper that Supervisor Forster referred to and feels that it gives a fair interpretation and highlights a lot of concerns and issues that Supervisor Axe mentioned today. He continued by noting Amador Fire Safe Council has also been requested to join the coalition as an intervener and after lengthy discussion have decided to join. Some reasons behind the decision to join were, but not limited to, if the filers of the subject suit are successful it will compromise the Amador Fire Safe Councils principle mission which is to reduce the threat of catastrophic wildfires that threaten local communities.
