The Hideout: Mr. John Munn, District III resident, took this time to remind the Board that the County has not yet taken action to enforce R1A zoning requirements against commercial operations at the Hideout owned by Mr. Tom Hoover. Mr. Munn continued by stating in addition to zoning restrictions, the Hideout is located at the end of a dead end roadway approximately two miles from Highway 88. Definitions included in Section 15.30.090 of the Amador County Code require a road to be used for commercial occupancy, and Section 15.30.210 specifies that a dead end road to a parcel larger than 20 acres cannot be longer than one mile. Mr. Munn stated the distance from Highway 88 to the Hideout is at least twice what is allowed under the current County Code, and use of the Hideout for commercial operations should be prohibited by County access requirements, in addition to the on-going zoning violations. He urged the Board to enforce existing

County Code requirements as they relate to the use of Mr. Hoover's property known as the Hideout.

**Code Enforcement**: Discussion and possible action relative to consideration of the Administration Hearing Board recommendation regarding the absence of a fence to secure a swimming pool at 12140 Colt Drive, Sutter Creek, CA (APN 040-120-007)

Mr. Glenn Spitzer, Deputy County Counsel, provided a brief summary of this matter by stating on February 20, 2020, and Administrative Abatement Hearing was held regarding the absence of a fence to secure the swimming pool on the above reference parcel. He noted the matter is before the Board for a decision to either adopt the Hearing Board's Findings and Recommendation without further notice or hearing or setting aside the matter and scheduling a de novo hearing.

Ms. Michelle Gallaher, Code Enforcement Officer, took this time to advise the Board she has been in contact with Mr. Vorrath on several occasions regarding the fence and although he realizes it is his responsibility to replace the fence he does not have the financial means to accomplish it at this time. Ms. Gallaher advised Mr. Vorrath has a classic car for sale on consignment in Rancho Cordova and has agreed to fix the fence upon sale of the vehicle.

Mr. Vorrath addressed the Board and stated he has been able to obtain an estimate from a Contractor for repair of the fence and intends to replace it as soon as he is financially able. He noted the estimate is in the amount of \$3,600.00 and if the Board agrees to provide a loan to him he would be able to make monthly payments until it was satisfied, or if the sale of his car occurs he will pay the balance in full.

- Within sixty (60) days of the date of the Board of Supervisors adopts the Hearing Board's recommendation:
  - 1. The Landowner shall remedy the condition with a fence that secures the pool and prevents access.
  - 2. The Landowner shall coordinate with the Code Enforcement Department and schedule an inspection of the remedied condition to occur within the 60-day period.
