Counsel Spitzer stated that there are some that want to.

Mr. Beatty explained that since Calaveras County clamped down on permits and Amador clamped down at the same time that interest in Amador County has pretty much gone away.

Commissioner Byrne shared that he assumes a larger volume is needed to be grown to make it worthwhile.

Mr. Beatty commented that there is not a lot of money with a few plants.

Commissioner Byrne added that if it is allowed it should be grown on much larger parcels.

Commissioner Curtis commented that he thinks that the plant still has blooms only the bloom is not used for hemp and it seems like a regulatory nightmare.

Counsel Spitzer stated that the issue is that it is hard to distinguish between cannabis that has the drug THC and hemp that does not. He added that it needs to be tested in a lab and becomes a regulatory nightmare.

Chair Gonsalves commented that he understands that there is concern or possible previous issues about cannabis being mixed in with the hemp and then transported illegally.

Counsel Spitzer agreed that it is another concern and regulatory nightmare.

Chair Gonsalves asked if there are any further comments.

No were no further comments.

**MOTION:** It was moved by Commissioner Curtis, seconded by Commissioner Kendrick, and carried to accept the CEQA exemptions as noted in the ordinance.
