\*\*It should be noted the start of the meeting was delayed approximately 20 minutes due to citizens expressing unhappiness regarding face masks being required to enter the Board Chambers. Approval of an Agreement with Blue Shield regarding the COVID-19 Vaccination Program (Blue Slip): Discussion and possible action relative to approval of the subject agreement.

Mr. Greg Gillott, County Counsel, addressed the Board and stated the proposed agreement was sent to the County on Saturday, February 20<sup>th</sup>. The State is insisting on very short approval timelines, demanding that the Agreement and related documents, be approved, signed, and returned within five business days.

Discussion ensued with the following action being taken.

Railroad Crossing Improvements: Discussion and possible action relative to a request for road closures of Michigan Bar Road and Carbondale Road.

Mr. Richard Vela, Public Works Director, addressed the Board and summarized the staff report relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, the Union Pacific Railroad (UPRR) is planning to complete repairs to crossings on the following roads in Amador County during the month of April:

- 1. Michigan Bar Road between Carbondale Road and the Sacramento County Line (4/5-4/8)
- Carbondale Road between Michigan Bar Road and Maxwell Road (4/12-4/15)
   Michigan Bar Road between SR 104 and Carbondale Road (4/19-4/22)

Each repair will require a full road closure at each location with an associated detour route in place for the duration of the work.

Ernesto Plasencia. Union Pacific Foreman was present via ZOOM to answer questions by the Board. Mr. Plasencia advised he will attempt to have the road closures as brief as possible and to have the repairs done timely and with the least inconvenience to the public.

Discussion ensued with the following action being taken.

It was moved by Supervisor Forster, seconded by Supervisor Oneto and unanimously carried to approve the requested road closures to facilitate the repairs to UPRR crossings on Michigan Bar Road and Carbondale Road as presented, and authorize the Director of Transportation and Public Works to act on the behalf of the County in the signing of necessary encroachment permit documents.

**Amador County Behavioral Health Advisory Board Annual Report**: Discussion and possible action relative to the subject report and a brief presentation by Dr. Arnold Zeiderman.

Dr. Arnold Zeiderman joined the meeting via ZOOM and summarized the subject report which is hereby incorporated into these minutes as though set forth in full.

**Letter of Public Convenience**: Discussion and possible action relative to a request for and On-Sale Beer & Wine Type 42 Alcohol and Beverage License: Discussion and possible action relative to a request by Cristobal Lara and Rachel Sutherland at 15917 State Highway 49 in Drytown, CA.

Mr. Greg Gillott, County Counsel, addressed the Board and summarized this matter for the Board. In summary, he stated the number of alcoholic beverage licenses are limited by State law, Pursuant to Business and Professions Coe section 23816, the number of On-Sale general licenses is capped based on a ratio of licenses to population (1 license per 2000 residents). According to ABC, the maximum ratio for on-sale licenses within the County is not exceeded. However, the number of licenses available within the County is further limited by census tract in order to avoid any "undue concentrations" of licenses in certain areas. The proposed Wine Café falls within Census Tract 2. ABC has indicated that all 13 on-sale licenses available for Census Tract 2 have already been issued. Therefore, the Applicant's request is reviewed pursuant to the "undue concentration" provisions located in the Business and Professions Code. There are other exceptions, but generally, ABC must deny the license unless the Board of Supervisors determines within 90 days of the notification that "public convenience or necessity would be served by the issuance of the license.

Cris Lara addressed the Board and explained a little of his business plan and the vision for the Tin Roof Café. Mr. Lara stated he is fully aware of the parking challenges and intends to work closely with all appurtenant County Departments to obtain all the necessary permits and satisfy all requirements and regulations.

Discussion ensued with the following action being taken.

**Amador County Redistricting Advisory Committee:** Discussion and possible action relative to appointment of members to the subject Committee and discussion regarding the process as it moves forward.

Mr. Chuck Iley, County Administrative Officer, addressed the Board and stated the U.S. Census Bureau announced recently that it will deliver the Public Law 94-171 redistricting data to all states by September 30, 2021. COVID-19 related delays and prioritizing the delivery of the apportionment results delayed the Census Bureau's original plan to deliver the redistricting data to the states by March 31, 2021. Different from previous censuses, the Census Bureau will deliver the data for all states at once, instead of on a flow basis.

This change has been made because of COVID-19-releated shifts in data collection and in the data processing schedule and it enables the Census Bureau to deliver complete and accurate redistricting data in a more timely fashion overall for the states.
