## MINUTES

The Redistricting Advisory Committee of Amador County met at the County Administration Center, 810 Court Street, Jackson, California, on the above date pursuant to adjournment, and the following proceedings were had, to wit:

**PLEDGE OF ALLEGIANCE:** Chairman Keith Sweet led the Committee and the public in the *Pledge of Allegiance*.

**PUBLIC MATTERS NOT ON THE AGENDA:** Discussion items only, no action to be taken. Any person may address the Committee at this time upon any subject within the jurisdiction of the Amador County Redistricting Advisory Committee; however, any matter that requires action may be referred to staff and/or Committee for a report and recommendation for possible action at a subsequent Committee meeting. **REVIEW OF REDISTRICTING REQUIREMENTS:**

Chairman Sweet welcomed the committee and went over basic housekeeping guidelines and also stated his personal preferences on how the committee will operate. Chairman Sweet would like the Committee to move forward with an objective and to have a consensus opinion from the ten of us to present to the Board for their consideration. If we can't reach consensus then the committee will vote on it and go by the majority. Chairman Sweet asked the committee if there were any questions. Hearing none at this time, Chairman Sweet moved forward identifying the task of this committee is to present the Board of Supervisors by the end of October with one or two maps for their consideration and in between that time there are other things to be done. Chuck Iley, Chief Administrative Officer (CAO), mentioned there are some intermediate tasks such, as identifying communities of interest, and also having a joint hearing with the Board to discuss along the way. Chairman Sweet provided an overview of the webinar(s) from The Rural County Representatives of California (RCRC) and The California State Association of Counties (CSAC) to the committee and outlined guidelines he would like to see the committee follow, such as, developing input, following proper processes and striving for outreach/public input.

**REVIEW OF CURRENT DATA, CENSUS DESIGNATED PLACES, & COMMUNITIES OF INTEREST:**

Ruslan Bratan, Amador County Planner, announced the launch of a website (hub) that he'd created and navigated through the hub with the committee on how it will greatly assist along in their process. Chairman Sweet asked for two volunteers to work with Vice Chair Katva Anderson and come back to the committee with recommendations for community outreach forms that we might use. Members Wayne Garibaldi and Tom Patten were appointed by the Chair.
