Amador COVID-19 Update

Amador County, CA – Amador County Public Health reports 8 more cases of COVID-19 since last Tuesday's update, bringing the total laboratory confirmed case count to 1,809. The new cases include 4 males and 4 females, 2 children under the age of 18, 3 aged 18-49, 2 aged 50-64, 1 age 65 and above; 6 residing in lone, and 2 living in Plymouth/surrounding areas.

This week, Amador County remains in the least restrictive yellow (minimal risk) tier within [California's Blueprint for a Safer Economy](#). On June 15, 2021 California shifts to the [Beyond the Blueprint](#) framework. This framework includes alignment with the Centers for Disease Control and Prevention (CDC) masking guidance for the general public. As of next Tuesday, June 15th, those who are fully vaccinated do not need to physically distance or wear a face covering indoors. Masking will still be required for those working in healthcare, high-risk congregate settings, or within a workplace where vaccination status is unknown. Outdoors, both fully vaccinated and unvaccinated, do not need to wear a mask except for outdoor mega events with over 10,000 attendees.

Employers will be subject to the [Cal/OSHA COVID-19 Prevention Emergency Temporary Standards \(ETS\)](#), if applicable to them, and CDPH will continue to provide updated guidance for high-risk settings.

Over 31,700 doses of COVID-19 vaccine have been administered to Amador residents to date. 58.9% of Amador County residents have had at least one dose of vaccine. 13,900 Amador residents age 12 and older are fully vaccinated. If you missed your second dose appointment there are multiple options for COVID-19 vaccination within the county and surrounding areas. To find a COVID-19 vaccine appointment at nearby pharmacies, visit the [Vaccines.gov website](#). The map is searchable by vaccine brand and zip code, up to a 50-mile radius. Jackson CVS, Safeway, Walgreens, and Walmart pharmacies are all offering COVID-19 vaccine by appointment. Vaccine appointments are scheduled via their respective websites. Residents may also reach out to their health care provider to inquire if vaccine is available within their health care system.

All Amador County residents and visitors are encouraged to do their part in order to stay safe and stay open. All who wish to be immunized should make a vaccination appointment by visiting the [My Turn](#) website or the [Vaccines.gov](#) website.
