**Buena Vista Rancheria**: Mr. Bill May, District II resident, took this time to address the Board relative to a matter that is on the Closed Session agenda for today's date. Mr. May spoke in regards to item 2.a. (Buena Vista Rancheria) and urged the Board to please provide more information when reporting out of Closed Session. Mr. May stated he does not feel the usual report of "**Update Given**" is a transparent or fair report for the public's information.

The Board reconvened into Closed Session upon the conclusion of Mr. May's comment.

<u>PLEDGE OF ALLEGIANCE:</u> Chairman Axe led the Board and the public in the *Pledge of Allegiance*.

PUBLIC MATTERS NOT ON THE AGENDA: Discussion items only, no action to be taken. Any person may address the Board at this time upon any subject within the jurisdiction of the Amador County Board of Supervisors; however, any matter that requires action may be referred to staff and/or Committee for a report and recommendation for possible action at a subsequent Board meeting. Please note - there is a three (3) minute limit per person.

Homelessness Issue in City of Jackson: Mr. Richard Cavaliere, District I resident, addressed the Board and stated he is a resident of the City of Jackson and has great concern regarding Homeless encampments behind his home that are an extreme fire and health and safety issue. He would like to see a procedure put in place that would be a broad approach to Homelessness throughout the County, including the Cities. Mr. Cavaliere stated he is aware the Board will be discussing this matter later in the agenda today, but was unsure if that topic would include potential solutions for residents within the City limits of Amador County. Chairman Axe advised his concerns would be addressed when Item 4b is heard today.

We Are Never Alone (WANA) Group: Mr. Michael Eslinger, Homeless and Mental Support Advocate, addressed the Board regarding the WANA group that was established in Amador County by a group of volunteers to assist those in need with mental health resources and support with finding the assistance they may need. Mr. Eslinger state WANA is a peer support based program and utilizes donated items to support their efforts. He stated the goal of WANA is to develop resources that can offer support, dignity, pride and self-worth to unhoused or mentally challenged individuals in the Community

**Amador Water Agency Rate Increase**: Mr. Sean Kriletich, District II resident, took this time to express great concern regarding the proposed rate increases by the AWA and encourage attendance at the AWA Public Hearing on July 27, 2021 at 6:00 p.m. to make their concerns known.

Mule Creek State Prison Wastewater Discharge: Mr. Bill May, District II resident, addressed the Board and expressed concern regarding the delay in action being taken to remedy the issues surrounding waste water discharge from Mule Creek State Prison and the detrimental affect it is having on Ione area residents. In addition Mr. May requested County Counsel disclose to him the costs associated with outside legal fees surrounding this matter to date. The Board directed Counsel to release the costs to Mr. May via email as soon as possible.

County Code 19.48.080 (g): Mr. Gary Reinoehl, District V resident, addressed the Board and explained a situation regarding one of his neighbors who received a Notice of Violation from Amador County Code Enforcement citing violation of County Code Section 19.48.080 as it relates to recreational vehicles. Mr. Reinoehl stated he is speaking on behalf of his neighbor as she is recently widowed and slightly overwhelmed navigating through the estate details. He stated she has a trailer on her property which has a deck affixed to it. According to his interpretation of County Code the deck is allowed if it does not exceed sixteen days per year in use. When Mr. Reinoehl contacted the County Planning Department he was advised it was an unwritten standard amongst Planning/County staff that the deck would be in violation. Mr. Reinoehl requested the Board agendize this matter for a future agenda and suspend the current violation deadline until the Ordinance can be revised to clarify specific standards and make the requirements clear to the property owners and public.

U.S. Forest Service: Mr. Jon Campbell, District IV resident, addressed the Board regarding the recent fires in Alpine County (Tamarack Fire). Mr. Campbell state he would like to urge the Board to draft a letter to the US Forest Service and others stating the recent fires have been horribly mismanaged and that the response by the USFS is unacceptable and cannot be repeated in the future.

Mr. Chuck Iley, County Administrative Officer, explained that the Buena Vista Casino Fund currently has a deficit balance of \$1,796,212.40. The deficit is a result of the Buena Vista Casino not paying the County for Public Safety and Gambling Abuse per the Intergovernmental Services Agreement. The County hired employees in all the Public Safety Departments (Sheriff, Probation and District Attorney) designed to mitigate the impacts of the Buena Vista Casino.

**COVID-19 Update**: Update by the Amador County Health Officer, Dr. Rita Kerr on the COVID-19 situation and the progress on the road to reopening Amador County.

Dr. Rita Kerr, Amador County Public Health Officer, joined the meeting via ZOOM and took this time to provide an update of the current status of the COVID-19 situation including vaccine supply in Amador County. **General Services Administration**: Amador County Parcel # 044-100-027 (210.37 acres adjacent to Walmart on SR 88). General discussion and direction relative to a large number of individuals living without facilities on the property.

Mr. Jon Hopkins, General Services Director, addressed the Board and summarized his memorandum relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, he stated the County owns 201.37 acres known as the "Wicklow Way" property in Martell and leases a majority of the property for cattle grazing. However, there are portions of the property not used for this purpose. A section of the property located behind Walmart not used for cattle grazing is being used by the homeless. A core group of County staff are working on solutions to clear and clean this area up, in the meantime this area is being driven on to transport items back and forth to homeless camps. Mr. Hopkins explained the key issue at this time is funding to clear and clean the property and to block of vehicle traffic on the Wicklow Way property. In addition, Mr. Hopkins requested consideration to amend policy 5-140 that provides some additional guidelines and clarifications specific, but not limited to, storage of property that is removed from the encampments. (It should be noted a complete copy of the proposed amendments to Policy 5-140 are included in agenda materials for today's date)

Chairman Axe invited the following individuals to speak relative to the impacts they are facing in their Departments as well as proposed proactive plans of action to assist in remediating this serious issue and being in the Community.

Mr. Roger Pitto, County Surveyor, addressed the Board and explained there is still some misunderstanding and missing information surrounding this matter. In summary, he stated in his opinion, the Barbero's made and agreement with the Dalton's regarding the piece of property that is being proposed to be abandoned for a Public Utility Easement. But, before the agreement was consummated the Barbero's sold the entire ten acre property to Ms. Kathleen Roberts. At this point Mr. Pitto does not have a clear chain of title that puts anyone other than the Daltons in a position to close the request for the Boundary Line Adjustment. Mr. Pitto stated he has requested copies of the agreement between the Barbero's and the Dalton's but has not received it as of today's date.

Discussion ensued with County Counsel recommending this Public Hearing be closed until when or if the involved parties can resolve all of the outstanding issues and the matter can be set for Public Hearing again for the Board to take action. The Board concurred with Counsel's recommendation and the following action resulted.
