For Amador, the priorities were specifically stated as being "in no particular order", so just re-ordering them to a tiered format or so they are in order of priority would be a huge benefit.

When we get closer to HHAP Round 2, I will be matching up the county priorities with the similar HHAP priorities to make scoring easier for the Review & Rank Committee. The idea is that the projects that most closely meet the highest priorities for their county will score higher than others, and therefore will be more likely to receive funding.
