ITEM 1: Review and possible approval of a hazard tree removal permit; 50817 Merrill Road, Kirkwood, CA; APN 026-141-003; Applicant: Baxter.

Brendan Ferry introduced the item, and after the discussion, Tri-TAC members agreed that the project was approvable as presented.

On a motion by Chuck Beatty and a second by Brendan Ferry, the Committee recommended approval of the project.

ITEM 2: Review and possible approval of a hazard tree removal permit; Lot 5, Unit 2 East Meadows Subdivision, Kirkwood, CA; APN 006-143-005; Applicant: Patterson.

Brendan Ferry introduced the item. Steve Cannon, registered professional forester, spoke on the item. The parcel has a conservation easement and the project is aimed at

forest health and fire safety. 60 trees are to be removed, but only 19 were marked due to many of the trees being very small.

After the discussion, Tri-TAC members agreed that the project was approvable as presented.

Dear Mr. Peters,

On the 2nd of August I visited the residence of Mr. Michael Browner at 279 Larkspur Lane in Kirkwood, CA.

The purpose of my visit was to assess the status of the trees on his property and to determine if any of the trees constituted a hazard to his house or to human safety.

What I found was that there are 4 trees that I would recommend removing and a description of them is as follows:

Tree #1 – An 44" diameter Red fir. It is heavily infested with the parasite Dwarf Mistletoe, has three dead tops and is likely suffering from Annosus root rot. If this tree were to fall to the south, it is large enough to cause significant damage to the house.

Tree #2 - A 18" diameter Red fir. This tree is dead.

Tree #3 – A 16" diameter Red fir. This tree is dead.

Tree #4 - An 8" diameter Red fir. This tree is dead

I marked the trees with their respective numbers in yellow paint. Tree #1 is on the north side of the Browner house and Tree #s 2, 3, & 4 are on the east side of the house, in the back yard.



Dear Mr. Peters.

On the 2nd of August I visited the residence of Dr. Robert Goldberg at 347 Larkspur Lane in Kirkwood, CA.

The purpose of my visit was to assess the status of the trees on his property and to determine if any of the trees constituted a hazard to his house or to human safety.

What I found was that there are three trees that I would recommend removing and a description of them is as follows:

Tree #1 - A 14" diameter Red fir. This tree is located near the northeast corner of the house and the tree is dead.

Tree #2 – A 40" diameter Red fir. This tree is within 70 feet of the house on the south side and presents a danger to the house. It has a dead top and infested with Dwarfmistletoe. The needles are fading, indicating the progression of the Annosus root rot. A Red fir in this situation is also prone to attack by the Fir Engraver beetle.

Tree #3 – A 12" diameter Red fir. This tree is near the northeast corner of the house and is dead, with rot showing at the base of the tree.

I marked the trees with their respective numbers in yellow paint.
