Item 1: Public Scoping Session to take public comments on the potential environmental impacts to be analyzed in the Draft Environmental Impact Report for the proposed Ione Quarry Expansion Project. (APNs 005-080-016 and 005-080-020)

Applicant: Specialty Granules Ione, LLC

Supervisorial Districts: 2

Location: 1900 Highway 104, Ione, CA, 500 feet east of the intersection with Michigan Bar Road, and approximately two miles west of the City of Ione

Acting Chair Byrne introduced the item and shared that the proponent has a PowerPoint to share and asked for confirmation that it is being shared via Zoom.

Mr. Beatty stated that printed copies of the PowerPoint are available, that an online version is available on the County website, and that the presentation will be screen-shard for those participating by Zoom. He then shared the Staff Report which is hereby incorporated by reference into these minutes as though set forth in full.

Ms. Manges confirmed that the PowerPoint is being shared with those participating via Zoom.

Mr. Beatty stated that the purpose of the scoping session is to obtain comments from the public and commenting agencies on the scope and breadth of the environmental impact report that will be prepared for this project. He added that it is less about project comments or approval or denial of the project at this stage. He stated that at the end of this session the Planning Commission can direct the project proponents on what areas under CEQA to study in the environmental impact report.

Acting Chair Byrne prompted the proponent to begin the presentation.

Kevin Moore, Director of Mine Planning and Capital of Specialty Granules, introduced himself and George Diaz, Site Manager at the Ione facility, Lori Dayton, Senior Permitting Specialist, and Pat Mitchell from Mitchell Chadwick. He and Mr. Diaz shared a PowerPoint containing a brief overview of the company, what work is performed at the Ione facility, and information about the expansion project.

Members of the public who commented that evening included: Mike DeSpain, Buena Vista Rancheria of Miwok Indians Natural Resources Director; Emily Maloney, Buena Vista Rancheria of Miwok Indians Water Program Coordinator; Ivan Senock, Buena Vista Rancheria of Miwok Indians Tribal Historic Preservation Officer; Susan Bragstadt, Susan Port; unidentified caller; Alise Bradshaw; Sondra West-Moore.

- trucks without covers
- dust
- gravel and debris on road
- accountable for traffic cost share
- air quality
- noise
- analyze impacts to groundwater by mining
- groundwater and storm water pumped into Loch Lane Lake, Dry Creek, and the Mokelumne River
- deep wells pulling water out of shallow aquafers
- pumping of impaired water into protected waters and discharge permits
- reinjecting impaired water back into the ground rather than discharging as surface water
- quarry pit lake effects depriving other surface waters like ponds, lakes, wet meadows, etc.
- · effects of blasting agents on groundwater, surface water, soil, and air for nitrates and other things
- monitoring plan for hydrocarbons that can impact surface and ground water
- storm water basin plans and permits

environmental document will be created. Most of his comments were seen in the letters received.

Commissioner Wardall asked that comments be included in the initial EIR.

Commissioner Bennett stated that dust is most commented upon and asked how Castle Oaks came about.

Mr. Beatty commented from the City of Ione was responsible for environmental review and approval of that project.

Commissioner Curtis shared that there are a lot of good comments and that he expects that most of them will be answered at some time. He understands the concerns and that the operators of the quarry understands them and will address them in an appropriate manner.

Commissioner Bennett noted that sphere of influence is supposed to prevent jurisdictional problems.

Mr. Beatty shared that the quarry was about two miles from lone's sphere of influence.

Acting Chair Byrne said we are seeing a jurisdictional conflict and is also concerned about a 150 year project and not sure if can predict the environmental impacts that far out.

Mr. Beatty said that future conditions of approval could include periodic monitoring.

Acting Chair Byrne asked why going out that far and that the length of time has cumulative effects and should be explored. Tonight's meeting cannot really address that, but after draft environmental document is out it can.

Counsel Spitzer added that the length of the permit could impact what proposed mitigation measures are in the EIR. He shared that it can be addressed with different alternatives and that the mitigation measures would flow from those alternatives.

Mr. DeSpain relayed that he wants everyone to know that the Buena Vista Tribe is the owner of Harrah's NorCal, but to be aware when the Tribe is making comments regarding environmental documents that it is the Tribe, itself. He stressed the importance that the permit should be looked at for review every 5 or 10 years.

Acting Chair Byrne said that the point is well taken and asked if economic impact can be studied with local business.

Counsel Spitzer responded that it can be looked at, but is not an environmental impact per CEQA.

There were no other public comments.
