**Administrative Agency**: Update on Tree Mortality mitigation activities by Tad Mason, TSS Consultants, Dr. Richard Harris and Ed Struffenegger.

Mr. Tad Mason, TSS Consultants, joined the meeting via ZOOM, summarized the item and then introduced Dr. Richard Harris to provide the presentation.

Dr. Richard Harris presented and informative Power Point outlining a summary of the program since the project began in 2017 as well as observations of new mortality and plans for remediation going forward. Dr. Harris also took this time to summarize project reimbursement data. (A complete copy of the Power Point presentation is hereby incorporated into these minutes as though set forth in full.)

General Services Administration: Discussion and possible action relative to the Community Economic Resilience Fund (CERF).

Mr. Jon Hopkins, General Services Director, addressed the Board and summarized the staff report relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, the Community Economic Resilience Fund (CERF) was created to promote a sustainable and equitable recovery from the economic distress of COVID-19 by supporting new plans and strategies to diversify local economies and develop sustainable industries that create high-quality, broadly accessible jobs for Californians. Mr. Hopkins stated the CERF Leadership Team was responsible for the development of geographic regions and boundaries that can administer the program's funding and work. The regions are defined in a way that promotes geographic equity and is consistent with existing economic development efforts as well as other definitions of regional economic markets. Mr. Hopkins continued by stating while the Amador region is inclusive of the Central Sierra Economic Development District (CSEDD) the CERF region also includes Inyo and Mono counties and is deemed as the Eastern Sierra Region.

At this time, Mr. Hopkins introduced Mr. Steve Frisch, Sierra Business Council, who joined the meeting via ZOOM and provided an informative presentation of the Community Economic Resilience Fund which is hereby incorporated into these minutes as though set forth in full.

Mr. Jeff Gardner, Director of Solid Waste, addressed the Board and summarized the staff report relative to this matter which is hereby incorporated into these minutes as though set forth in full. In summary, he stated ACES Waste Services, Inc. entered into a new franchise agreement with Amador County effective June 23, 2020, with a term of fifteen (15) years. As provided in the Agreement, the Company has requested a Rate Review for purposes of setting rates effective January 1, 2023, per Section 12.5 of the Agreement following the procedures as set forth in Attachment G to the Agreement. Under the terms of the Agreement, the Company's target profit level was reduced from 87.5% operating ratio to a 90% operating ratio, which equates to a target profit level of 11.1% on allowable expenses. Mr. Gardner advised staff engaged R3 Consulting Group Inc. to work on the Annual Rate Adjustment application.

At this time, Mr. Gardner introduced Mr. William Schoen, R3 Consulting, who joined the meeting via ZOOM and provided a presentation of the final report and fielded questions from the Board.
