## **Public Hearings**

Request for Use Permit Application UP-22;2-2 Wing It Food Truck, to be located within Martell Plaza parking lot alongside an existing commissary kitchen. The property is 3.37 acres, and is zoned MM, Medium Manufacturing and has a General Plan Designation of RSC, Regional Service Center. Operating hours will be 12 p.m. to 6 p.m. and the concession trailer will be run by up to 4 employees. (APN: 044-010-012)

Location: 12275 Martell Rd. Jackson, CA 95642

Acting Chair Bennett introduced the item.

Ms. Ruesel shared the Staff Report which is hereby incorporated by reference into these minutes as though set forth in full. She stated that the Draft Conditions of Approval shared at the meeting are an accumulation of comments received regarding the project and were part of the uploaded documents. She added that operating hours and number of employees have been added to the Draft Conditions of Approval.

Acting Chair Bennett asked if the proponent is present and if they want to comment.

Mr. Duarte shared that AWA previously had a concern about where wastewater will be dumped. He shared that he will be dumping at Sierra Septic and that Michelle Opalenick, Director of Environmental Health, is aware of this.

Ms. Ruesel said that it has been included as a condition in the Draft Conditions.

Commissioner Munnerlyn asked for clarification about where the 4 employees will be located and if the operating hours of 12-6 hours include the prep.

Mr. Duarte responded that 4 employees are broken up over several days and there will be only two employees working at the same time inside the trailer. He added that the hours of operation include the trailer, only.

Commissioner Curtis asked with airport flyover zone, is it exempted because there is no outside dining.

Ms. Ruesel commented that the Airport Land Use Commission (ALUC) recommended that there only be take out with no seating. She added that in the future the proposed Draft Airport Safety Plan could allow outside dining.

Commissioner Curtis questioned whether the applicant is aware of this.

Mr. Duarte responded that he is aware.

Acting Chair Bennett commented that fat and grease should be disposed of separately. He stated that Supervisor Brown shared with him that there are potential dangers for outdoor seating from lead from

airplane exhaust.

Acting Chair Bennett opened the public hearing.

There was no further public comment.

Item 2 - Request for Zoning Ordinance Amendment (ZOA-22;5-1) to extend the initial terms of permits for temporary mobile homes and recreational vehicles occupied for disaster relief and during construction of a single family dwelling, and to decrease the minimum size of a single family dwelling from 800 square feet to 360 square feet.

**Applicant:** County of Amador **Supervisorial District:** All

Location: Amendments would be applicable all residentially-zoned and

agriculturally zoned parcels in the unincorporated areas of Amador County.

Acting Chair Bennett introduced the item.

Mr. Beatty shared the Staff Report which is hereby incorporated by reference into these minutes as though set forth in full.

Acting Chair Bennett asked if the code changes affected duplexes.

Mr. Beatty responded that it can as long as building code is met.

Acting Chair Bennett opened the public hearing.

David Evitt, Sutter Creek, stated that he did not hear any recommendation from Planning or the Technical Advisory Committee (TAC).

Mr. Beatty responded that TAC has no objection to the Planning Commission recommending approval to the Board of Supervisors.

Acting Chair Bennett said that he is used to the extended family being the norm and is in favor of this.

Commissioner Curtis stated that all 3 items seem very reasonable.

Commissioner Munnerlyn stated that she also agrees, especially with the changing of the minimum size which is still above the average size of a tiny house in America.

Acting Chair Bennett asked for any further public comment or any further discussion. There was none.
