

# HTF Meeting Minutes for 11-16-21

## 1. Public Comment

- Al Bierce described an article that he had read in the San Francisco Chronicle about a Tiny Home village in Oakland. Each unit cost about \$7,500 each and had electrical connection to it. Al was going to look into it and bring it back to the group. Steve Christensen and Ashley from operation care wanted to participate too.

## 2. No Place Like Home Update

Update on the NPLH project from Stephanie Hess

- Danco the housing development sponsor has selected a property and taken control of the site to build 46 units of apartments.
- The original site selected earlier was not satisfactory with the City of Sutter Creek.
- Danco signed an agreement and has taken control of another site in Sutter Hill.
- Property is located at 942 Par 2 Way in Sutter Hill and is roughly 2.06 acres
- Danco will be responsible for the construction and administration of the future apartments, while Amador County will be responsible for supportive services for mental health from HHS
- The NPLH project will be discussed at the Board of Supervisors on Tuesday November 23<sup>rd</sup>, 2021

## 3. Transitional Housing Update

Update by Denise Cloward (ATCCA) on transitional housing for Jackson

- Currently ATCAA has roughly \$900,000 in HAAP round 1 funding and the Whole person care funds.
- ATCAA has identified a 6 bedroom 2 bath house in the City of Jackson.
- The house will require a lot of work to fix it up and 2 out buildings will have to be demolished.
- They hope to be in escrow by the end of the week.
- John Murphy from St. Vincent de Paul re-iterated its offer to provide furnishings to
- ATCAA will be applying to the City of Jackson for a use permit to operate a shelter at that location and will be enlisting letters of support from the City of Jackson Police department and others.
