June 30, 2023 – August 22, 2023	Vote by Mail ballot requests – Military and Overseas voters only <a href="#">EC § 300(b), 3103</a>
July 31, 2023	Last day to mail a Vote by Mail ballot to initial voter list <a href="#">EC § 3001, 3003, 3006, 3009</a>
August 22, 2023	Last day to request a Vote by Mail ballot <b>by mail</b> <a href="#">EC § 3001</a>
August 23, 2023 – August 29, 2023	A Vote by Mail ballot request can be submitted <b>over the counter</b> at Elections Office <a href="#">EC § 3003</a>
August 29, 2023 – September 5, 2023	A Vote by Mail ballot must be postmarked by August 29 <sup>th</sup> and received by September 5 <sup>th</sup> <a href="#">EC § 3017, 3020</a>
