ORDINANCE NO. 1605

The Board of Supervisors of the County of Amador ordains as follows:

SECTION I. Sections 10.12.095, 10.12.160, 10.12.210, 10.12.230, 10.12.270, and 10.12.370 of the Amador County Code are hereby repealed.

SECTION II. Section 10.12.015 is hereby added to Chapter 10.12 of said Code to read as follows:

"Section 10.12.015 Penalties for Violation.

- A. Any person, firm or corporation violating any of the provisions of this Chapter 10.12 is guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not exceeding one hundred dollars, or imprisonment for not more than thirty days in the county jail or by both such fine and imprisonment.
- B. In addition to any fines or other penalties which may be imposed, any vehicle parked in violation of any section of this Chapter may be removed to the nearest storage facility at the expense of the registered owner thereof, by or under and at the direction of a peace officer, and the person causing such movement and storage of the vehicle shall immediately, by the most expeditious means, notify the owner of the vehicle of its location. If, for any reason, the vehicle's owner cannot be so notified, the person causing the vehicle to be moved and stored shall immediately, by the most expeditious means, notify the Sheriff's department of the County and the nearest office of the California Highway Patrol.
- C. No vehicle may be removed and stored pursuant to this section unless signs indicating that no person shall stop, park or leave standing any vehicle within the area marked by the signs are erected at least twenty-four hours prior to any enforcement thereof."

SECTION III. Section 10.12.410 is hereby added to Chapter 10.12 of the Amador County Code to read as follows:

A10.12.410 Restricted Parking - Jackson Valley Road, County Road No.78. No person shall stop, park, or leave standing any vehicle, whether attended or unattended upon either side of Jackson Valley, County Road No. 78, twenty-three hundred and seventy-five feet (2375 ft.) from State Highway 88 to the Greenstone Quarry entrance."

SECTION IV: In all other respects, the provisions of Chapter 10.12 of the Amador County (ORDINANCE NO. 1605)

Code shall remain in full force and effect.

SECTION V: This ordinance or a summary thereof shall be published in the manner prescribed in Government Code Section 25124 and shall become effective thirty (30) days after the date of adoption.
