

ORDINANCE NO. 1639

ORDINANCE AMENDING SUPERVISORS' SALARIES

The Board of Supervisors of the county of Amador ordains as follows.

Section 1. Section 2.04.090 of the Amador County Code is hereby repealed.

Section 2. Section 2.04.090 is hereby added to the Amador County Code as follows.

“2.04.090 Salaries and benefits.

A. Effective July 1, 2005, each supervisor for the county shall receive as compensation for services required of him/her by law or by virtue of his/her office the sum of two thousand nine hundred eighty-nine dollars and thirty cents for each month during which such supervisor holds office. Such salary shall be prorated for the first and last month of his/her term. The supervisor serving as chair shall be compensated an additional three hundred dollars for each month during which he/she serves as chair, and the supervisor serving as vice chair shall be compensated an additional two hundred dollars each month during which he/she serves as vice chair.

B. Effective July 1, 2006, each supervisor for the county shall receive as compensation for services required of him/her by law or by virtue of his/her office the sum equal to twenty-five percent of the Amador County superior court judge's monthly pay in effect on June 30, 2006, for each month during which such supervisor holds office. Each year thereafter, the board of supervisors' annual rate of compensation shall be adjusted on July 1st without further direction to the auditor-controller or personnel department. The annual rate of adjustment shall equal twenty-five percent of the Amador County superior court judge's salary in effect on July 1st of the same year. No additional compensation will be paid to the supervisor serving as chair or to the supervisor serving as vice chair effective July 1, 2006.

C. Effective July 1, 2007, each Supervisor for the County shall receive as compensation for services required of him/her by law or by virtue of his/her office the sum equal to thirty (30) percent of the Amador County Superior Court Judge's monthly pay in effect on June 30, 2007 for each month during which such Supervisor holds office. Such salary shall be prorated for the first and last month of his/her term. No additional compensation will be paid to the Supervisor serving as Chair or to the Supervisor serving as Vice Chair effective July 1, 2007.

D. Effective July 1, 2008, each Supervisor for the County shall receive as compensation for services required of him/her by law or by virtue of his/her office the sum equal to thirty-five (35) percent of the Amador County Superior Court Judge's monthly pay in effect on June 30, 2008 for each month during which such Supervisor holds office. Such salary shall be prorated for the first and last month of his/her term. No additional compensation will be paid to the Supervisor serving as Chair or to the Supervisor serving as Vice Chair effective July 1, 2008.

E. Effective July 1, 2009, each Supervisor for the County shall receive as compensation for services required of him/her by law or by virtue of his/her office the sum

equal to forty (40) percent of the Amador County Superior Court Judge's monthly pay in effect on June 30, 2009 for each month during which such Supervisor holds office. Such salary shall be prorated for the first and last month of his/her term. Each year thereafter, the Board of Supervisors' annual rate of compensation shall be adjusted on July 1st without further direction to the Auditor-Controller or Personnel Department. The annual rate of adjustment shall equal forty (40) percent of the Amador County Superior Court Judge's salary in effect on July 1st of the same year. No additional compensation will be paid to the Supervisor serving as Chair or to the Supervisor serving as Vice Chair effective July 1, 2009.

F. Each Supervisor shall accrue benefits as set forth in the most current resolution adopted for Management Unit employees, with the exception of vacation, sick leave, unemployment, and SDI benefits, provided, however, that each Supervisor shall receive six (6) days of sick leave credit for each year of continuous service for which they were elected, which credit may be used only toward PERS retirement credit. If a Supervisor elects not to participate in PERS, he/she may take the County's share of PERS in cash."

Section 2. In all other respects, the Amador County Code remains unamended and in full force and effect.

Section 3. This ordinance or a summary thereof shall be published in the manner prescribed in Government Code section 25123.5 and shall become effective sixty (60) days after the date of adoption.


