

ORDINANCE NO. 1746

AN ORDINANCE AMENDING CHAPTER 3.32 OF THE AMADOR COUNTY CODE

The Board of Supervisors of the County of Amador ordains as follows:

SECTION 1. Chapter 3.32, "DELINQUENT TAX COLLECTION", of the Amador County Code, is hereby amended to read as follows:

"Section 3.32.010. Installment Payments—Fee. Pursuant to the authority of Revenue and Taxation Code Section 4217 and Government Code Section 54985 et seq., a fee of one hundred dollars (\$100.00) is established to initiate the payment of delinquent taxes in installments (Five-Pay Plan) to the County Tax Collector."


SECTION 2. This ordinance shall be published within fifteen days after the date hereof in a newspaper of general circulation printed and published in the County of Amador, State of California, and shall become effective thirty days after the date hereof.

The foregoing ordinance was duly passed and adopted by the Board of Supervisors of the County of Amador at a regular meeting thereof, held on the 9<sup>th</sup> day of September, 2014, by the following vote:
