WHEREAS, the City Councils of Amador City, the City of Jackson, the City of Ione, the City of Plymouth, the City of Sutter Creek, the Amador County Unified School District, the Amador Water Agency and the Volcano Community Services District have called elections for November 3, 2020, for the purpose of voting on measures and offices; and

WHEREAS, the City Councils of Amador City, the City of Jackson, the City of Ione, the City of Plymouth, the City of Sutter Creek, the Amador County Unified School District, the Amador Water Agency and the Volcano Community Services District have requested that the Amador County Board of Supervisors consolidate said elections with the November 3, 2020 General Election and permit the Amador County Clerk-Recorder/Registrar of Voters to conduct said elections; and

WHEREAS, the City Councils of Amador City, the City of Jackson, the City of Ione, the City of Plymouth, the City of Sutter Creek, the Amador County Unified School District, the Amador Water Agency and the Volcano Community Services District have agreed that they will reimburse the County of Amador for all proportionate costs incurred for conducting the elections; and

WHEREAS, the California Elections Code §10002 authorizes such consolidation in the interest of economy; and

WHEREAS, the Amador County Clerk-Recorder/Registrar of Voters has determined that no unusual problems would arise from said consolidation.

NOW, THEREFORE, BE IT RESOLVED AND DIRECTED by the Amador County Board of Supervisors to consolidate the elections of Amador City, the City of Jackson, the City of Ione, the City of Plymouth, the City of Sutter Creek, the Amador County Unified School District, the Amador Water Agency and the Volcano Community Services District with the November 3 General Election to be held on November 3, 2020.

The foregoing resolution was duly passed and adopted by the Board of Supervisors of the County of Amador at a special meeting thereof, held on the 12th day of August 2020 by the following vote:
