WHEREAS, in compliance with Government Code section 7522.56 Amador County must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since his or her retirement date; and

WHEREAS, Holly Durrett, CalPERS ID 7329894003 retired from the Amador County Sheriff's Office in the position of Public Safety Dispatcher/EMD, effective January 31, 2019; and

WHEREAS, section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is August 1, 2019, without this certification resolution; and

WHEREAS, section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, Amador County, the Amador County Sheriff's Office and Holly Durrett certify that Holly Durrett has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, Amador County hereby appoints Holly Durrett as an extra help retired annuitant to perform the duties of Public Safety Dispatcher/EMD for the Amador County Sheriff's Office under Government Code section 21224, effective February 1, 2019; and

WHEREAS, the entire employment agreement, contract or appointment document between Holly Durrett and the Amador County Sheriff's Office has been reviewed by this body and is attached herein; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 177.333 to equal the hourly rate; and

WHEREAS, the maximum base salary for this position is \$4910.35 and the hourly equivalent is \$27.69, and the minimum base salary for this position is \$4039.65 and the hourly equivalent is \$22.75; and

WHEREAS, the hourly rate paid to Holly Durrett will be \$25.11; and

WHEREAS, Holly Durrett has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, BE IT RESOLVED THAT Amador County hereby certifies the nature of the employment of Holly Durrett as described herein and detailed in the attached employment agreement / contract / appointment document and that this appointment is necessary to fill the critically needed position of Public Safety Dispatcher/EMD for the Amador County Sheriff's Office by February 3, 2019, because critical staffing levels have fallen below acceptable and reasonable levels within the Amador County Sheriff's Office dispatch center and can only be filled by persons with highly specialized skills.
