WHEREAS, Thomas G. Sage, II was born on April 1, 1969 to Thomas and Pearl Sage in Glendale, California and moved to Amador County at age 9; and

WHEREAS, even as a boy of 10, Tom said that he wanted to be a peace officer; and

WHEREAS, Tom graduated from Amador High School in 1987; and

WHEREAS, in June of 1990 Tom was hired as a Deputy Sheriff with the Amador County Sheriff's Office, and during his tenure was assigned as a member of the SWAT team for four years, Search and Rescue team, Crime Specifics Unit, Marijuana Suppression Unit, DIVE team, and the Narcotics K-9 Unit for 2 years; and

WHEREAS, Tom married his wife, Lory, on July 26, 1997 and they have a beautiful daughter, Christina, and grandson, Daxton; and

WHEREAS, Tom was sworn in as a District Attorney Investigator on November 10, 1997, and during his tenure has been assigned to the Child Support Division, Welfare Fraud Division, General Investigations Unit, Workers' Compensation Fraud Unit; and

WHEREAS, Tom received his Advanced POST certificate in 1999, has attended the POST Supervisors school, and graduated from the 2009 FBI National Academy; and

WHEREAS, Tom was selected as the 2008 Amador County Peace Officer of the Year; and

WHEREAS, Tom was elected Secretary of the California District Attorney Investigators' Association in 2007, and served in that capacity until 2015, and was re-elected Secretary in 2017 through the present; and

WHEREAS, Tom was sworn in as Supervising District Attorney Investigator on July 15, 2010 and was sworn in as Chief Investigator on January 3, 2013; and

WHEREAS, during his tenure, Tom has assembled one of the most experienced, dedicated and talented investigative bureaus in California; and

WHEREAS, in Tom's 29 years as a peace officer, he has served the citizens and allied law enforcement agencies within Amador County and the State of California with dignity, respect, honor, and unmatched professionalism; and

WHEREAS, Tom has been instrumental in the success of the District Attorney's Office through his hard work, dependability, strong work ethic, and reliability; and

THEREFORE BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby recognize and congratulate Thomas Sage upon his retirement from Amador County.
