RESOLUTION AUTHORIZING THE APPOINTMENT OF GEORGE ALLEN AS INTERIM AMADOR COUNTY SURVEYOR PURSUANT TO GOVERNMENT CODE SECTIONS 7522.56 AND 21221(h)

**RESOLUTION NO.19-052** 

WHEREAS, Current County Surveyor Steve Zanetta retired from the County of Amador effective May 1, 2019; and

WHEREAS, George Allen, who had previously served as the Amador County Surveyor for 13 years before he retired on September 30, 2015, and possesses his Land Surveyor's License, has indicated that he is willing to temporarily serve as Interim County Surveyor; and

WHEREAS, an appointment of a CalPERS retiree under Gov. Code § 21221(h) requires an active, publicly posted recruitment for a permanent replacement; and

WHEREAS, the County is currently actively recruiting to fill the position of Surveyor, which has been publicly posted; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties and no other benefit, incentive, compensation in lieu of benefits, or other form of compensation can be paid in addition to the hourly rate; and

WHEREAS, the term of the appointment shall have a specific end date and the retiree can only be appointed once; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador that:

SECTION 1. George Allen is appointed as an interim appointment retired annuitant to the vacant position of County Surveyor under Gov. Code Sections 7522.56 and 21221(h), effective May 14, 2019.

SECTION 2. The Board of Supervisors finds that this appointment is necessary to fill the vital position of County Surveyor.

SECTION 3. The Board of Supervisors finds that George Allen has the necessary skills to perform these duties.

SECTION 4. This Gov. Code § 21221(h) appointment of George Allen to the vacant Surveyor position shall terminate as of the date a permanent Surveyor is hired and begins working for the County, or 1-year from the date of appointment (May 14, 2020), whichever occurs first.

SECTION 5. The employment shall be limited to 960 hours per fiscal year.

SECTION 6. George Allen will be paid an hourly rate that is equivalent to the monthly base salary for this position. He will not receive any other benefit, incentive, compensation in lieu of benefit, or other form of compensation in addition to this hourly pay rate.

SECTION 7. The County shall create a new appointment in CalPERS enrolling George Allen as a Retired Annuitant as set forth above and report all annuitant earnings and hours to CalPERS.
