Mental Health Rates Increase FY 19-20

Background:

Based on the county detailed cost report for Mental Health services for fiscal year 17-18, the costs per unit were higher than the published billing rates. The billing rates have not been changed since 2017.

### Key Issue:

In order to capture adequate reimbursement for costs of services provided, it is recommended that the published rates that are billed to Medi-Cal, insurance and those who do not qualify for a sliding scale rate, be changed using the Market Basket Index used by the Centers for Medicare and Medicaid Services. We have used the Fiscal Year 17/18 costs and increased 2% for Fiscal Year 18/19 and 2% for Fiscal Year 19/20 to establish new rates below.
