WHEREAS, Anne began serving in two positions — as Eligibility Worker I and as Social Worker I — on February 8, 1999 until March 1, 1999 when she began serving full time as Social Worker I; and

WHEREAS, Anne was promoted to Social Worker II on September 1, 1999; and

WHEREAS, Anne was promoted to Social Worker III on March 1, 2001 until April 3, 2006; and

WHEREAS, Anne was hired as Supervisor of APS/CPS/IHSS on February 4, 2008; and

WHEREAS, Anne was promoted to Program Manager of APS/CPS/IHSS on February 1, 2010 until her retirement October 1, 2018; and

WHEREAS, Anne had concurrently served as Interim Director of Social Services from August 25, 2011 to January 30, 2012; and

WHEREAS, Anne has shown great compassion and consideration to all Amador County residents who requested assistance in time of need and served on numerous commissions, councils, coalitions, and committees including: First 5 Commission, Child Abuse Prevention Council, Juvenile Justice and Delinquency Prevention Commission, Perinatal Wellness Coalition, Amador Resilient (Trauma Informed Care Coalition), Children's Multi-Disciplinary Team, School Attendance Review Board, and Juvenile Court Bench/Bar Meetings, to name a few; and

WHEREAS, Anne adapted to multiple changes in systems, State and Federal regulations governing assistance to children through the many Child Protective Service programs and to adults through Adult Protective Services and In-Home Supportive Services and was a very dedicated, devoted, professional employee who delivered excellent customer service throughout her years of employment with Amador County.

THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California that said Board does hereby adopt this resolution commending Anne Watts for her years of service to the people of the County of Amador.
