WHEREAS, the Amador County Tax Collector now desires to distribute the excess proceeds referred to under said Section 5e) to this new valid claimant;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby rescind the authorization and approval of the distribution of excess proceeds as set forth in Section 5e) of Attachment "A" to Resolution No. 17-058, and does further authorize and order that said excess proceeds resulting from the public auction sale conducted by the Amador County Tax Collector on March 16, 2016, be distributed as set forth in Attachment "A" hereto.
