WHEREAS, Kathleen has owned and operated a landscape design and consultation business for 37 years and is a certified arborist, author, and Master Gardener having worked on many projects in Amador, Calaveras and El Dorado counties, also volunteering at local schools with landscaping, tree planting and youth gardening; and

WHEREAS, Richard has served on the Board of Directors of the Amador County Chamber of Commerce and the original Board of the Amador County Recreation Agency and is currently President of the Board of Directors of Keystone Mines, Inc., as well as an elected official to the Amador City City Council for eight years, the last four years as Mayor; and

WHEREAS, Richard served on the Amador City Volunteer Fire Department for 3 years and is currently in his 19th year on the Sutter Creek Volunteer Fire Department, the last few years as Captain; and

WHEREAS, together, Richard and Kathleen created and organized an Annual Women's Shooting Clinic in 1997 with Richard as Head Instructor, and are members and officers of True Sportsman Club; and

WHEREAS, both Richard and Kathleen continue in their passion of shooting having created a youth shotgun team, coaching, managing, serving on Boards, and coordinating various youth and adult shooting clubs and championship meets, and training shotgun coaches by authoring "The Shotgun Coaches Primer."
