WHEREAS, invasive species negatively impact fish and wildlife populations, water resources, and recreational opportunities displacing native plant populations, altering communities and ecosystem processes, including hydrologic and fire regimes, clogging waterways, and degrading native habitats, water quality, recreational experiences, and aesthetic values; and

WHEREAS, invasive species are detrimental to California's agricultural industry and the economy by damaging crops, increasing production costs, and reducing yields, as well as by increasing operational costs for municipalities, hydroelectric power generation, and infrastructure; and

WHEREAS, the annual cost of invasive species to the economy of the United States is estimated at \$120 Billion, and the annual cost of impacts and control efforts are estimated to equal 5% of the world's economy; and

WHEREAS, local County Agricultural Commissioner's working in collaboration with the Board, other agencies, businesses, non-profits, concerned public, and agricultural industry are dedicated to excluding and controlling invasive pests; and

WHEREAS, the Amador County Board of Supervisors does hereby support all efforts to exclude and prevent the spread of invasive species, and encourages collaboration with groups to prevent the spread of invasive species, and efforts to educate the public to further the control of invasive species; and





INTENTION TO SELL .52 ACRE	)	
LOT IN IONE, CALIFORNIA	)	

BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California that as authorized by Government Code section 25526, said Board hereby declares its intention to sell certain real property located in Ione, California. Said real property is specifically described in Attachment "A" attached hereto (the "Property"), and said Board sets forth the following terms and conditions upon which the Property shall be sold; and

Said terms and conditions are as follows:

- (a) Buyer shall take title to the Property AS IS and with any existing encumbrances; and
- (b) As described in Exhibit A, the minimum price of the Property shall be \$5000.00 cash; and
- (c) A bid deposit of \$500.00 is required; and
- (d) Board hereby sets Thursday, August 20, 2015 at 1:30 p.m. at which time sealed bids will be opened and read publicly at the General Services Administration building located at 12200-B Airport Road, Martell, CA; and
- (e) General Services Director is directed to prepare a bid and informational package; and
- (f) General Services Director is authorized to open and read publicly bids received and to call for oral bids in accordance with Government Code Sections 25531 & 25539; and
- (g) Board hereby sets Tuesday, September 8, 2015 at 9:00 a.m. at which time any bids received on August 20, 2015 will be considered and comments from the public heard. Final acceptance of the highest bid shall be subject to the approval of the Board of Supervisors and said Board reserves the right to reject any and/or all bids; and
- (h) Real estate broker's commission shall be paid at the rate of 10% in accordance with the County's contract with Coldwell Banker Award Realtors. Said contract includes a provision of sharing the commission with the buyer's broker, if any; and

BE IT FURTHER RESOLVED said Board has acknowledged that the Amador County Planning Department has reviewed the requested action in accordance with the California Environmental Quality Act ("CEQA"). It can be seen with certainty that there is no possibility that the requested action may have a significant effect on the environment, and under the provisions of section 15061(b)(3) of the State CEQA Guidelines, the requested action is exempt
