WHEREAS, Phillip was assigned to the Amador County Combined Narcotics Enforcement Team on April 1, 2013 and was involved in numerous investigations which removed large amounts of controlled substances and resulted in numerous arrests for illegal narcotics trafficking; and

WHEREAS, in Phillips's 13 years as a peace officer, he has served the citizens within Amador County, the State of California, and the United States of America with dignity, respect, honor, and unmatched professionalism; and
