WHEREAS, Dick had a vision of opening a winery and began a planting program stressing older California varietals as well as Rhone varietals that would offer a unique niche; and

WHEREAS, Dick served as the acting Agricultural Commissioner while the County was searching for a permanent Commissioner; and

WHEREAS, Dick served as the Livestock Manager of the Amador County Fair for three years and Manager of the Amador County Fair for five years; and

WHEREAS, Dick is one of the original founders and past President of the Amador County Grape Growers Association; and

WHEREAS, in 2004 the doors of Cooper Vineyards tasting room were opened and the business continues to thrive today; and

WHEREAS, Cooper Vineyards is the venue for many charitable events every year including but not limited to, the Barbera Festival sponsored by the Amador Community Foundation, The Spaghetti Western benefitting cancer research at UC Davis Comprehensive Cancer Center as well as a benefit dinner in memory of Laura Spinetta supporting the Library Fund at Plymouth Elementary School; and

WHEREAS, Dick has four daughters Jennifer, Rochelle, Jerry and Chrissy who are all involved in essential components of the winery, tasting room and ranch operations; and

WHEREAS, Dick has five grandchildren, Marcus Swift who authors the very clever and descriptive tasting notes, Eric Swift who is the resident IT expert, Rose Cooper-Housler who keeps tasting room guests entertained with her wine knowledge and contagious wit, and Cooper and Peyton Cheetham who are soon to follow in the footsteps of their older cousins and continue the tradition of family involvement in the winery and ranch; and
