WHEREAS, Section 2635 of the California Revenue and Taxation Code provides that when the amount of taxes paid exceeds the amount due by more than \$10.00, the Tax Collector shall mail notice of the overpayment to the taxpayer at the taxpayer’s last known address, said notice to state the amount of overpayment and that a claim for refund may be filed; and

WHEREAS, Section 5097 of the Revenue and Taxation Code provides that no refund may be made except on a verified claim filed within one year after the mailing of the notice as prescribed in the above-referenced Section 2635; and


WHEREAS, Section 5102 of the Revenue and Taxation Code provides that if no claim is filed within the time allowed, the overpayment may be transferred to the County General Fund on order of the Board of Supervisors; and

WHEREAS, with regard to the Assessments Numbers and refund amounts shown on “ATTACHMENT A” hereto, the required notices have been mailed, no claims for refund have been received, and the time for filing claims for such refunds has expired.


THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby authorize and order the Amador County Treasurer/Tax Collector to transfer all such property tax refund amounts shown on the said “ATTACHMENT A” hereto, to the County General Fund, pursuant to the provisions of the Revenue and Taxation Code Sections referred to above.
