WHEREAS, Ted worked as a Dispatcher for the San Leandro Police Dept. then for the State of California with the CDF at Sutter Hill, the CYA in Pine Grove, Cal Trans in Ione, the CCC in Fricot City, and retiring as a firefighter from the CDC in Stockton; and

WHEREAS, Ted is currently one of two Assistant Battalion Chiefs within the AFDPD Battalion 10; and

WHEREAS, Ted joined the Pine Grove Fire Department in February, 1976; and

WHEREAS, for over 36 years Ted has responded to calls for medical aid, vehicle accidents, various types of fires, hazmat conditions and public assists; and

WHEREAS, Ted maintains fire apparatus, equipment, facilities and supplies for AFDPD Battalion 10.


