WHEREAS, Weldon "Linc" Lincoln was born on September 17, 1949 to Weldon A. and Marcella Lincoln in Glendale, California; and

WHEREAS, Linc remained in Southern California until 1967 when he joined the U.S. Marine Corps, completing boot camp at MCRD in San Diego before being stationed at Camp Pendleton, subsequently served his Country in the First Battalion, 26 Marine Delta Company in Vietnam and was wounded in action during the siege at Khe Sanh; and

WHEREAS, in 1978 Linc settled in Northern California, eventually ending up in Amador County, and married his wife Cindy; and

WHEREAS, in 1985 Linc began his law enforcement career with the Amador County Sheriff's Office as a Jailer/Dispatcher and soon after attended the Basic Law Enforcement Academy at Butte College and was hired as an Amador County Deputy Sheriff in 1986; and

WHEREAS, in 1991 Linc was assigned to the Detective Division and was promoted to Sergeant in 1997; and

WHEREAS, Linc accepted the position of Supervising Investigator with the Amador County District Attorney's Office in 2000, and was promoted to Chief Investigator in 2010; and

WHEREAS, Linc has been instrumental in the success of the District Attorney's Office through the investigations he has conducted, the leadership he has exhibited, and the care and compassion he has shown to the victims of our community; and

WHEREAS, Linc's greatest joy is his family, including his wife Cindy, his daughter Amanda, and his two grandsons, Matthew and Nathaniel; and


THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby recognize Weldon "Linc" Lincoln for his selfless dedication to the District Attorney's Office, local law enforcement and the citizens of Amador County, and congratulate him upon his retirement after 27 years of service.


